Sub: Diversion of 3.104 ha of forest land for construction of 11 KV overhead Transmission line from Jaldihi village to Jumka-Pathiriposhi Pahar Iron Ore Block of M/s Rungta Mines Ltd. in Sundargarh District, Odisha under Bonai Forest Division - Stage-I Compliance regarding.

Ref:- Letter No.5-ORB589/2023-BHU dated 22.12.2023 of the Deputy Inspector General of Forests (C), Govt. of India, MoEF&CC, Regional Office, Bhubaneswar.
Sir,

In inviting a reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Regional Office, Bhubaneswar has accorded Stage-I/In-principle approval vide Letter letter No.5-ORB589/2023-BHU dated 22.12.2023 for diversion of 3.104 ha of forest land for construction of 11 KV overhead Transmission line from Jaldihi village to Jumka-Pathiriposhi Pahar Iron Ore Block of M/s Rungta Mines Ltd. in Sundargarh District, Odisha under Section 2 of Forest (Conservation) Act, 1980 subject to fulfilment of 12 nos. of conditions prior to handing over of forest land by the State Forest Department and 21 nos. of conditions after handing over of forest land to the user agency by the State Forest Department stipulated therein. The point wise compliance basing on the reports of DFO Bonai Forest Division and RCCF, Rourkela Circle are as follows:-

A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

Condition No. (i) :The user agency shall transfer online, the Net Present Value (NPV) of 3.104 ha. forest land being diverted under this proposal, as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2011-FC (Vol-I) dated 06.01.2022 and 19.01.2022. The requisite funds shall be transferred through online portal in CAMPA account of the State concerned.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, the User Agency was demanded a sum of ₹ 44,59,424/- vide Letter No.10116 dt.29.12.2023 of DFO, Bonai Forest Division towards NPV @Rs.14,36,670/- per ha (Eco-Class-I, Canopy density 0.65) for the entire forest land over 3.104 ha involved in the said project area.

Accordingly, the User Agency has deposited the said amount of ₹44,59,424/- through online on 16.1.2024 vide UTR No.CNRBR52024011671801423, and the payment particulars ins enclosed as **Annexure-1**.

Condition No. (ii): *The identified non-forest land for raising compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, an area of 5.00 Ha. of Govt. Non-Forest land in village Talabarada under Banspal Tehsil of Keonjhar District in Keonjhar Forest Division has been identified for Compensatory Afforestation. The Non-Forest land has already been transferred and mutated and accordingly RoR has been issued in favour of State Forest, Environment & Climate Change Department, Govt. of Odisha.

Further, the said non-forest Govt. land identified in village Talabarada under Banspal Tehsil of Keonjhar District over 5.00 ha for CA has been declared as "Talabarada PF" under Section-33 of the Odisha Forest Act, 1972 vide Notification No.FE-DV-FLD-0074-2023-(10F-(Cons)-54/2023)14083/FE & CC dated 01.08.2024 by the Additional Chief Secretary to Govt., Govt. of Odisha. The copy of RoR and PF Notification are enclosed as **Annexure-2 Series**.

Condition No. (iii): *The land identified for the purpose of Compensatory Afforestation shall be clearly depicted on a Survey of India Topo sheet of 1:50,000 scale.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, the Non-Forest land over 5.00 ha. in village Talabarada under Banspal Tehsil of Keonjhar District in Keonjhar Forest Division identified for Compensatory Afforestation has been clearly depicted on survey of India Topo Sheet No.F45N2 of scale 1:50,000. The Toposheet is enclosed enclosed as **Annexure-3**.

Condition No. (iv): *The KML files of the area to be diverted and the CA areas shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear project or submitting compliance report for seeking Stage-II approval, as the case may be.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, the KML file of the area to be diverted and the CA areas have been uploaded on the e-green watch portal.

Condition No. (v): *The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, an area of 5.00 ha. of Govt. non-forest land has been identified in village Talabarada under Banspal Tehsil of Keonjhar District in Keonjhar Forest Division for Compensatory Afforestation.

The above Compensatory Afforestation Scheme has been approved by the PCCF (FD & NO FC Act), Bhubaneswar for ₹34,32,500/-. Further, the User Agency has deposited the said amount of ₹34,32,500/- through online on 20.1.2024 vide UTR No.CNRBR52024012072139463. The approval letter of PCCF (FD & NO, FC Act) and deposit slip are enclosed as **Annexure-4 Series**.

The approved CA scheme will be implemented and maintained by the Divisional Forest Office, Keonjhar Forest Division, the scheme also include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

Condition No. (vi): *The user agency in consultation with the State Forest Department shall prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal species) in right of way under the transmission line and provide funds for execution of the said scheme by the State Forest Department.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, a scheme for creation and maintenance of plantation of Dwarf species in right of way under the transmission line has been technically approved by RCCF, Rourkela with a total financial outlay of ₹20,69,200/-.

Further, the User Agency has deposited the above approved amount of ₹20,69,200/- through online on 04.03.2024 vide UTR No.CNRBR52024020773324682. The payment particular is enclosed as **Annexure-5**.

Condition No. (vii): *As recommended by the State Govt. a Site Specific Wildlife Conservation Plan shall be prepared and duly approved by CWLW, Odisha and to be implemented at project cost.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, this proposal is a linear proposal associated with Jumka-Pathiriposhi Pahar Iron Ore Block of M/s Rungta Mines Ltd. along with approach road from Belkudar to Jumka Pathiriposhi Mines.

Therefore, a composite Site Specific Wildlife Conservation Plan addressing the long term mitigating strategy plan and monitoring mechanism with respect to wild animals and specially Human-Elephant Conflict (HEC) in the region has been approved by the PCCF

(Wildlife) and CWLW, Odisha vide Memo No. 4707 dt.25.4.2024 (**Annexure-6**) in respect of Jumka-Pathiriposhi Pahar Iron Ore Block including the instant proposal over 3.104 ha of forest land for construction of 11KV transmission line and the proposal over 13.077 ha of forest land for construction of approach road from Jumka-pathiriposi Pahar Iron Ore Block to existing Koira-Belkudar Patamunda Road for ore transportation with a financial outlay of ₹9,04,44,000/- for implementation of activities in the Zone of influence (ZOI) in Bonai & Keonjhar Forest Division.

The User Agency has deposited ₹9,04,44,000/- towards cost of Site Specific Wildlife Conservation Plan through e-portal of MoEF & CC (<http://parivesh.nic.in>) on 08.05.2024 vide UTR No.CNRBR52024050879953412 as per Challan dated 08.05.2024. In respect of diversion of 156.978 ha forest land in Jumka-Pathiriposhi Iron Mines. The copy of payment details are enclosed as **Annexure-7**.

Condition No. (viii): *The user agency shall pay for the Regional Wildlife Management Plan approved by the State Govt. covering the entire mining belt of Bonai and Keonjhar Forest Division as per the prescribed cost norm.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, an amount of ₹3,20,022/- was demanded vide his office Letter No.881 dt.3.2.2024 to pay towards the cost of Regional Wildlife Management Plan fund over 3.104 ha. of entire project area @ ₹1,03,100/- per ha.

Accordingly, the User Agency has deposited ₹ 3,20,022/- through e-portal of MoEF & CC (<http://parivesh.nic.in>) on 07.02.2024 vide UTR No.CNRBR52024020773324682. The copy of payment details is enclosed as **Annexure-8**.

Condition No. (ix): *All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal (<https://parivesh.nic.in/>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, all funds received from the User Agency under the project have been transferred / deposited in CAMPA account only through e-portal (<https://parivesh.nic.in/>).

The statement of funds deposited by the user agency towards compensatory levies duly signed by the DFO, Bonai Forest Division and countersigned by the PCCF (FD & Nodal Officer, FC Act) is enclosed as **Annexure-9**.

Condition No. (x): *The compliance report of the Stage-I approval shall be uploaded on e-portal (<https://parivesh.nic.in/>).*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the compliance report has already been uploaded on e-portal.

Condition No. (xi): *The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificates from the concerned District Collector.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, the Collector, Sundargarh has issued certificate under Forest Right Act, 2006 over 3.104 ha. of forest land vide his Letter No.1208/ITDA (FRA) dt.24.04.2023. The copy of FRA certificate is enclosed as **Annexure-10**.

Condition No. (xii): *The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, the Range Officer, Barsuan Range has intimated vide his Memo No.429 dt.21.6.2024 that the boundary of the proposed forest land for diversion has been demarcated on ground at project cost by erecting four feet high RCC pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates. The letter of the Range Officer, Barsuan and the list of detail pillar positions are enclosed as **Annexure-11 & 12** respectively.

B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.

Condition No. (i): *Legal status of forest land proposed for diversion shall remain unchanged*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the legal status of the forest land proposed for diversion shall remain unchanged which is enclosed as **Sl. No.2 of Annexure-13**.

Condition No.(ii): *Compensatory afforestation shall be raised over 5.00 of non-forest Govt. land in Plot No.7 (P) & 9 (P), Khata No.24 Kisam Parbat-I of village Talabarada under Banspal Tahasil of Keonjhar District of Keonjhar Forest Division within two years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department, at the cost of user agency. The species to be planted in the CA scheme shall be of native species of the area. At least 18 month old seedlings should be planted. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that, an area of 5.00 ha of Govt. Non-Forest land has been identified in village Talabarada under Banspal Tehsil of Keonjhar District and in Keonjhar Forest Division for Compensatory Afforestation.

The above Compensatory Afforestation Scheme has been approved by the PCCF (FD & NO FC Act), Bhubaneswar vide Memo No.25319 dt.27.12.2023 for ₹34,32,500/-. As per approved Scheme it has been proposed to take up AR model @ 1600 seedlings over 1.00 ha and @1000 seedlings/ per ha over 2.00 ha with 18 month old seedlings of native species are to be planted. The scheme has provision for soil moisture conservation measures with Angle Iron Chain Link wire mesh fencing around the plantation area.

Further, as reported by the DFO, Bonai Division, the User Agency has deposited the said an amount of ₹34,32,500/- through online on 20.1.2024 (Copy already attached as **Annexure-4**).

The above approved CA scheme will be implemented and maintained by the Divisional Forest Office, Keonjhar Forest Division.

Condition No.(iii): At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India which is enclosed at **Sl. No.3 of Annexure-13**.

Condition No. (iv): The base of towers in forest area to be fenced with barbed wire to avoid elephant electrocution/death of wild animals especially in forest areas. The concerned DFO shall inspect the area and shall take a decision as to the specific towers which shall be along with the leg of the towers.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the base of towers in forest area to be fenced with barbed wire to avoid elephant electrocution/death of wild animals especially in forest areas. The concerned DFO shall inspect the area and shall take a decision as to the specific towers which shall be along with the leg of the towers which is enclosed at **Sl. No.4 of Annexure-13**.

Condition No. (v): In hilly slope areas, sufficient ground clearance has to be maintained with additional height of towers in consideration of the sag and swing of lines and height of elephants to stop untoward incidence of electrocution as per existing guidelines of MoEF & CC dated 05.05.2014 and 19.11.2014.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to this effect which is enclosed at **Sl. No.5 of Annexure-13.**

Condition No. (vi): *The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to this effect which is enclosed at **Sl. No.6 of Annexure-13.**

Condition No. (vii): *The user agency shall explore the possibility of successful transplantation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that they shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits which is enclosed at **Sl. No.7 of Annexure-13.**

Condition No. (viii): *The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No.7-25/2012-FC dated 05.05.2014 and 19.11.2014.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that they shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No.7-25/2012-FC dated 05.05.2014 and 19.11.2014 which is enclosed at **Sl. No.8 of Annexure-13.**

Condition No. (ix): *The user agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1980, if applicable.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the User Agency has intimated in his compliance that as per EIA Notification 14.9.2006 Environmental Clearance is not required for this project.

Condition No. (x): *No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that no labour camp shall be established on the forest land and the user agency shall provide

fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas which is enclosed at **Sl. No.9 of Annexure-13.**

Condition No. (xi): *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that no additional or new path will be constructed inside the forest area for any activity related to the project work which is enclosed at **Sl. No.10 of Annexure-13.**

Condition No. (xii): *The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that while executing works, they shall not fell any tree or damage forest growth in the surrounding forest area in any manner which is enclosed at **Sl. No.11 of Annexure-13.**

Condition No. (xiii): *The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed at **Sl. No.12 of Annexure-13.**

Condition No. (xiv): *The forest land shall not be used for any purpose other than that specified in the proposal.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the forest land shall not be used for any purpose other than that specified in the proposal which is enclosed at **Sl. No.13 of Annexure-13.**

Condition No. (xv): *The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the forest land proposed to be diverted shall under no circumstances be transferred to any

other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed at **Sl. No.14 of Annexure-13.**

Condition No. (xvi): *No damage to the flora and fauna of the adjoining area shall be caused.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that no damage to the flora and fauna of the adjoining area shall be caused which is enclosed at **Sl. No.15 of Annexure-13.**

Condition No. (xvii): *The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the DFO, Bonai Forest Division will adhere to this condition.

Condition No. (xviii): *The user agency shall submit annual self-monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that they shall submit annual self-monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year which is enclosed at **Sl. No.16 of Annexure-13.**

Condition No. (xix): *Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency which is enclosed at **Sl. No.17 of Annexure-13.**

Condition No. (xx): *The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.*

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division

that the State Govt. and user agency shall ensure compliance to provisions of all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project which is enclosed at **Sl. No.18 of Annexure-13.**

Condition No. (xxi): Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter I of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.

Compliance: In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter I of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019 which is enclosed at **Sl. No.19 of Annexure-13.**

In view of the above, the compliance to the conditions imposed by Government of India, MoEF & CC, Regional Office, Bhubaneswar is sent herewith for according final approval for diversion of 3.104 ha of forest land for construction of 11 KV overhead Transmission line from Jaldihi village to Jumka-Pathiriposhi Pahar Iron Ore Block of M/s Rungta Mines Ltd. in Sundargarh District, Odisha under Section 2 of Forest (Conservation) Act, 1980.


