Sub: Proposal for non-forestry use of 48.782 ha of forest land for the construction of 220 KV LILO transmission line from existing LoC No.70 of 220 KV Balimela-Malkangiri Transmission line to existing 220/33 KV Grid S/S Khairput, Gobindapalli under Malkangiri Forest Division in Malkangiri District by OPTCL, EHT Construction Division, Jeypore, Odisha- Stage-I compliance regarding.

Ref:- Stage-I approval order dated 27.11.2024 of the Assistant Inspector General of Forests (C), Govt. of India, MoEF&CC, FC Division, New Delhi Sir,

In inviting a reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, FC Division, New Delhi have accorded Stage-I/In-principle approval order dated 27.11.2024 for non-forestry use of 48.782 ha of forest land for the construction of 220 KV LILO transmission line from existing LoC No.70 of 220 KV Balimela-Malkangiri Transmission line to existing 220/33 KV Grid S/S Khairput, Gobindapalli under Malkangiri Forest Division in Malkangiri District by OPTCL, EHT Construction Division, Jeypore, Odisha under Section 2 (1) (ii) of Van (Sanrakhsan Evam Samvardhan) Adhiniyam, 1980 subject to fulfillment of 29 nos. of conditions prior to handing over of forest land and after handing over of forest land to the user agency by the State Forest Department stipulated therein. The point wise compliance based on the reports of the DFO, Malkangiri Forest Division and the RCCF, Koraput Circle is furnished as follows:-

Condition No.1: Legal status of forest land proposed for diversion shall remain unchanged.

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that the legal status of the forest land shall remain unchanged which is enclosed as **Annexure** –**A**.



Condition No.2: Compensatory Afforestation:

i. Compensatory Afforestation over degraded forest land, double in extent to the forest land being diverted i.e. 97.564 ha, shall be raised by the State Forest Department at the project cost as per applicable guidelines;

ii. The User Agency shall transfer the cost of raising and maintaining the Compensatory Afforestation as per the approved CA Scheme at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal;

iii. The cost of survey, demarcation and erection of permanent pillars, if required on the identified CA land, shall be deposited in advance with the Forest Department by the user agency. The CA will be maintained for 10 years. The scheme may include Afforestation of indigenous species with appropriate provision for anticipated cost increase for works scheduled for subsequent years;

Compliance: In compliance to the conditions, the RCCF, Koraput Circle has reported that the Addl. PCCF (FD & NO, FC Act) vide their Memo No.25629 dt.19.12.2024 has approved the CA Scheme with 10 years of maintenance over an area of 97.564 ha of degraded forest land in Raginiguda PRF with a financial outlay of Rs.5,52,77,000/-. The DFO, Malkangiri Forest Division has also demanded the approved amount to the User Agency vide his letter No. 7208 dt.24.12.2024. Accordingly, the User Agency has deposited Rs.14,20,16,000/-(Rs.7,00,84,000/- towards cost of NPV + Rs.1,66,55,000/- towards cost of penal NPV + Rs.5,52,77,000/- towards cost of CA) vide PIF No.0471120250303910053 dated 03.03.2025. The deposit particulars informed by the User Agency to the DFO, Malkangiri Forest Division vide their letter No.95 dt.07.03.2025, the copy of approved financial outlay of the CA Scheme, the demand letter of the DFO, Malkanagiri Division and payment particulars made by the UA etc are enclosed as Annexure – B, C, D & E respectively.

Condition No.3: Net Present Value:

i. User Agency shall transfer the funds towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 06.01.2022 read with 22.03.2022 through online portal of CAMPA account of the State Concerned;

ii. At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India);

Compliance: In compliance to the above conditions, the RCCF, Koraput Circle has reported that the DFO, Malkangiri Forest Division has demanded the NPV amount including the Penal NPV amount to the User Agency vide his Letter No.751 dt.06.02.2025. Accordingly, the User

Agency has also deposited an amount of Rs.14,20,16,000/- (Rs.7,00,84,000/- towards cost of NPV + Rs.1,66,55,000 towards cost of penal NPV amount + Rs.5,52,77,000/- towards cost of CA) vide PIF No.0471120250303910053 dated 03.03.2025. The deposit details informed by the User Agency to the DFO, Malkangiri Division vide letter No. 95 dt.07.03.2025, the payment particular made by the User Agency, the Demand letter of the DFO, Malkangiri Division and undertaking furnished by the User Agency regarding payment of addl. NPV etc duly countersigned by the concerned DFO, are enclosed as **Annexure** – **B, E, F & G** respectively.

<u>Condition No.4:</u> Compensatory levies to be realized from the User Agency under the project shall be transferred/deposited, through e-payment module on PARIVESH portal (https://parivesh.nic.in/), into the account of CAMPA of the State concerned, managed by the National Authority (CAMPA);

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that, the user agency has furnished an undertaking to transfer all the Compensatory Levies online in Odisha State CAMPA account duly countersigned by the concerned DFO which is enclosed as Annexure – H. Regarding proof of payment of all the Compensatory Levies made by the User Agency, the 12 Point CAMPA format duly signed by the DFO, Malkangiri Forest Division and countersigned by the Addl. PCCF (FD & NO, FC Act) is enclosed as Annexure-H1.

<u>Condition No.5:</u> The KML files of diverted area, the CA areas, the proposed SMC treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details prior to 'Final' approval;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that all the required KML files as submitted by the User Agency has been uploaded on the e-Green watch portal.

Condition No.6: The State Govt. shall take action against the erring official under section 3A/3B of the Adhiniyam;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the DFO, Malkangiri Forest Division has submitted the connected documents like (1) action taken report of the Tahasildar Kudumuluguma regarding booking of encroachment cases against M/s OPTCL under Section-4, 6 & 7 of the OPLE Act, 1972 and accordingly, penalty imposed under Section-6 of the said act for unauthorized occupation on the above Revenue Forest land. (2) Action taken by the Forest Department by booking of a forest offence case by Range Officer, Balimela Range against the OPTCL vide OR Case No.79 of 2023-24 under Section-33 (C) of Odisha Forest Act, 1972, (3) drawing of one departmental proceeding against Sri Sasanka Kumar Das, Forest Guard in charge of Somnathpur Beat

under Balimela Range for negligence in Govt. duty and suppression of facts vide O.O. No.229 dated 12.06.2025 of the DFO, Malkangiri Forest Division etc. which are enclosed as **Annexure-I and Annexure-J Series** respectively.

<u>Condition No.7:</u> The State Govt. shall realize Penal NPV of forest land per ha per each year of violation from the date of actual diversion as reported by the inspecting officer with maximum up to 5 times the NPV plus 12% simple interest from the date of raising of such demand till the deposit is made;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the DFO, Malkangiri Forest Division has demanded the NPV amount including Penal NPV amount to the User Agency vide his Letter No.751 dt.06.02.2025. Accordingly, the User Agency has also deposited Rs.14,20,16,000/- (Rs. 7,00,84,000/- towards cost of NPV + Rs.1,66,55,000 towards cost of penal NPV + Rs. 5,52,77,000/- towards cost of CA). The deposit details informed by the User Agency to DFO, Malkangiri Division vide his letter No. 95 dt.07.03.2025, payment particulars made by the User Agency, the demand letter of the DFO, Malkangiri Forest Division against the User Agency vide his letter No.751 dated 06.02.2025 regarding payment of NPV amount, Penal NPV calculated over the violated area of 0.04 ha and 4.235 ha respectively with 12% simple interest from the date of raising of such demand till the deposit is made etc. are enclosed as Annexure – B, E, F & G respectively.

<u>Condition No.8:</u> The matter regarding imposition of penal CA is under consideration for the formulation of a uniform policy guideline in the matter. Keeping this in view, the imposition of penal CA (if any) shall be as per the said guideline, if issued;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**K**.

<u>Condition No.9:</u> The maximum width of right of way for the proposed transmission line on the forest land shall not be more than 35 mtrs;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that the maximum width of right of way for the proposed transmission line on the forest land shall not be more than 35 mtrs which is enclosed as **Annexure** –**L**.

Condition No.10: The User agency shall comply with the guidelines for laying of transmission lines through forest areas issued by the Ministry;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall comply with the guidelines for laying transmission lines through forest areas issued by the Ministry which is enclosed as Annexure –M.

Condition No.11: The user agency shall install circuit breakers at suitable places besides maintain necessary ground clearance to prevent electrocution of wild animals;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall install circuit breakers at suitable places besides to maintain necessary ground clearance to prevent electrocution of wild animals which is enclosed as **Annexure** –**N**.

Condition No.12: No approach road shall be constructed in the forest area for transportation of steel and other material required for the transmission line. As far as possible the User Agency shall use the existing road and the proposed RoW for the transportation of the material and in the event of non-availability of such facilities, the User Agency shall transport material manually without construction of any path;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**O**.

<u>Condition No.13:</u> To minimize the felling of trees for construction of transmission line, user agency shall comply with the following guidelines:

i. Below each conductor, width clearance of 3.0 mts. would be permitted for carrying the tension stringing equipment. The trees on such strips may be felled but after stringing work is completed, the natural regeneration will be allowed to come up.

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**P**.

ii. One outer strip may be left clear to permit maintenance of the transmission line;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**Q**.

iii. In the remaining width of the right of way felling/pollarding/pruning of trees will be done with the permission of the local forest officer whenever necessary to maintain the electrical clearance, trees shall be allowed to be felled or lopped to the extent required, for preventing electrical hazards by maintaining the minimum 4.6 meter clearance between conductors and trees. The sag and swing of the conductors are to be kept in view while working out the minimum clearance mentioned as above;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**R**.



iv. User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line, and provide funds for execution of the said scheme to the State Forest Department; and

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the DFO, Malkangiri Forest Division vide his Memo No.1084 dt.21.02.2025 has submitted the scheme on dwarf species (preferably medicinal plants) plantation in the right of way under the transmission line to his office. Accordingly, the RCCF, Koraput Circle has also approved the scheme sent vide his Memo No.733 dt.25.02.2025 at a financial outlay of Rs.1,13,37,500/-.

The DFO, Malkangiri Forest Division has demanded to the User Agency vide his Memo No. 1284 dt.06.03.2025 for deposit of the said approved amount. Accordingly, the User Agency has also deposited an amount of Rs.1,13,37,500/- in the State CAMPA Account, Odisha through e-portal. The dwarf species plantation scheme approval letter, the demand letter of the DFO, Malkangiri Forest Division and the payment particulars made by the UA vide PIF No.0471120250320919913 dated 20.03.2025 etc. are enclosed as **Annexure** – **S,T, U & V** respectively.

v. In case a portion of the transmission lines to be constructed is located in hilly areas, where adequate clearance is already available, trees shall not be cut;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**W**.

<u>Condition No.14:</u> The user agency will ensure that all the compensations, as per the norms and rules of the State Government to the affected persons shall be paid prior to handing over of forest land to the User agency;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall ensure that all the compensations, as per the norms and rules of the State Government to the affected persons shall be paid prior to handing over of forest land to them which is enclosed as **Annexure** –**X**.

<u>Condition No.15:</u> User agency will ensure that forest area nearby shall not be encroached upon due to implementation of the project;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall ensure that forest area nearby shall not be encroached upon due to implementation of the project which is enclosed as **Annexure** –**Y**.

Condition No.16: The State Government shall ensure that the minimum number of trees/plants/poles in any case not more than mentioned in the applied forest area will be

removed and the trees should be felled under strict supervision of the State Forest Department;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that the State Government shall ensure that the minimum number of trees/plants/poles in any case not more than mentioned in the applied forest area will be removed and the trees shall be felled under strict supervision of the State Forest Department which is enclosed as **Annexure** –**Z**.

<u>Condition No.17:</u> The cost of felling of trees shall be deposited by the User Agency with the State Forest Department;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the user agency has deposited an amount of Rs.1,15,23,599/- in favour of the Odisha Forest Development Corporation Ltd. in their Bank Account No.391301010030028 vide their letter No.184 dated 06.05.2025 as per the estimate submitted by the OFDC Ltd. to the User Agency vide their Letter No.2025/12L/1011 dated 13.04.2025 and Letter No.2025/24L/293 dated 12.04.2025 and as per request of the DGM, E.H.T (C) Division, Jeypore, OPTCL to the DM, OFDC Ltd. Jeypore, C-KL Division vide their Letter No.141 dated 02.04.2025 towards the cost of felling of trees standing over the forest area proposed to be diverted. The details of the above correspondences etc. are enclosed as **Annexure-AA**.

<u>Condition No.18:</u> The user agency shall explore the possibility of translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the user agency has agreed with the above stipulated condition and has complied the same in the Diversion Proposal.

<u>Condition No.19:</u> The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that being a linear project, the Environment Clearance is not applicable as per the provisions of the Environmental (Protection) Act, 1986, which is enclosed as Annexure-AB.

Condition No.20: The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted and submit the documentary

evidence, in accordance with the Rule 11 (7) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported the FRA certificate pertaining to this project has already been obtained over 48.782 ha of forest land proposed to be diverted by the User Agency vide Letter No.254/2024 dated 27.12.2024 of the Collector & District Magistrate, Malkangiri District along with Gram Sabha Resolutions, SDLC and DLC Committee proceedings etc. which are enclosed as Annexure- AC Series.

<u>Condition No.21:</u> No labour camp shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that no labour camp shall be established on the forest land and they shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas which is enclosed as Annexure -AD.

<u>Condition No.22:</u> The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that the forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government, which is enclosed as **Annexure** -AE.

<u>Condition No.23:</u> The State Govt. shall implement the R&R Plan as per the R&R Policy of State Government in consonance with National R&R Policy, Government of India before the commencement of the project work and implementation. The said R&R Plan will be monitored by the State Government/Regional Office of MoEF&CC along with indicators for monitoring and expected observable milestones;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking to that effect duly countersigned by the DFO, Malakangiri Forest Division which is enclosed as **Annexure** –**AF**.

<u>Condition No.24:</u> No damage to the flora and fauna of the adjoining area shall be caused;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri

Forest Division that no damage to the flora and fauna of the adjoining area shall be caused, which is enclosed as Annexure -AG.

<u>Condition No.25:</u> Any other condition that the concerned Regional Office of this Ministry may stipulate with the approval of competent authority in the interest of conservation, protection and development of forests & wildlife;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division to abide by any other condition that the concerned Regional Office of the Ministry may stipulate with the approval of competent authority in the interest of conservation, protection and development of forests & wildlife which is enclosed as Annexure -AH.

<u>Condition No.26:</u> The user agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall comply all the provisions of all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project, which is enclosed as Annexure -AI.

Condition No.27: Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed in para 1.16 of Chapter 1 of the Consolidated Guidelines and Clarifications on Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 as issued by this Ministry's letter dated 29.12.2023;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken against them as prescribed in para 1.16 of Chapter 1 of the Consolidated Guidelines and Clarifications on Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 as issued by this Ministry's letter dated 29.12.2023 which is enclosed as Annexure -AJ.

<u>Condition No.28:</u> The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government, concerned Regional Office and to this Ministry by the end of March every year regularly;

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has furnished an undertaking duly countersigned by the DFO, Malakangiri Forest Division that they shall submit the annual self-compliance report in respect of the



above stated conditions to the State Government, concerned Regional Office and to the Ministry by the end of March of every year regularly which is enclosed as **Annexure** -AK.

<u>Condition No.29:</u> The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).

Compliance: In compliance to the condition, the RCCF, Koraput Circle has reported that the User Agency has already uploaded the Stage-I compliance report on e-portal (https://parivesh.nic.in). However, the user agency has furnished an undertaking in this regard duly countersigned by the DFO, Malkangiri Forest Division which is enclosed as Annexure-AL.

In view of the above, the compliance to the conditions imposed by Government of India, MoEF & CC, FC Division, New Delhi is sent herewith for according final approval for non-forestry use of 48.782 ha of forest land for the construction of 220 KV LILO transmission line from existing LoC No.70 of 220 KV Balimela-Malkangiri Transmission line to existing 220/33 KV Grid S/S Khairput, Gobindapalli under Malkangiri Forest Division in Malkangiri District by OPTCL, EHT Construction Division, Jeypore, Odishaunder Section 2 (1) (ii) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.
