Above Cited subject its requested to regarding of objections raised in Sr. No.3 by the Government of India vide its letter No.-9-PBB405/2022-CHA dated 10/2022 in the above mentioned proposal you are requested that the KML file of the total land bank area in the case is 3.63 ha in which CA site of 3 other cases have been proposed apart from this case for approval under FCA 1980. The area of three KML files 2.189 ha also included in the total land bank area. Apart from these three cases the above case in which only 128 plants are to be planted, for which KML has been prepared, its area is only 0.180ha. It would be appropriate to inform you here that in the estimate sent for this case, there is no mention of fencing on the perimeter of 1.28 km. In this case only Round Brush wood fencing extraction cutting carriage material (with binding) to the 128 plants recorded in series number 18 of the estimate which is sent by this office vide letter No.190 dated 04-05-2022. It is also requested that there was no mention for fencing of 1.28 km in estimate of the above case. According to approved estimate the required fee has been deposited from user agency CA, Addl. CA and NVP. No fee has been deposited by user agency for fencing of 1.28 km area.
