**Sub: - Diversion of 2.95135 ha of forest land for M/s Vindhya Telelinks Pvt. Ltd. for laying optical fibre cable from Ferozepur-Faridkot Road KM 28.200 to 31.200 Mt, Turning point Village Allewala to Village Mallanwala Qadim on NH 05= 3200 Mt, Village Bazidpur to Mudki on FZR-MDK road- 23000 Mt, Mudki Chowk to Turning point Lungiana Kalan on Mudki-Baghapurana from KM 0-16.3=16300 Mt, Chungi No. 7 to Satti wala Chowk on Zira road FZR= 1300 Mt, Sadiq chowk to Village Machaki Kalan KM 18.400-10.300=8100 Mt, Zira-Jatra road 2600 Mt, Jatra road to Longiwind, Near canal-7930 Mt. Total length 65430 Mtr. under forest Division Ferozepur (FP/PB/OFC/119120/2021).**

1. The Stage-I approval was accorded to the proposal vide letter No - **FCA0FC1F/31/2021-FCA/I/332308/2022 dated 14.03.2022.** Divisional Forest Officer, Ferozepur has reported vide letter no. **4541 dated 17.10.2022.** Government of India has accorded general approval under the Forest Conservation Act, 1980 vide letter No. 11-9/98-FC dated 08-04-2009 dated 02.02.2015 in the cases of laying of Underground Telephone Lines, Optical Fiber Cable/Underground Laying of Drinking Water Supply Pipeline.

The Nodal Officer FCA has been authorized by the State Government to issue Final Approval vide e-office file no. 38957. After careful examination of the proposal under General Approvals issued by Govt. of India vide letter No. F.No. 5-2/2017-FC dated 28.03.2019, **“Stage-II approval”** is hereby conveyed for diversion of **2.95135 ha.** of forest land for digging of trenches measuring **65430 mtrs.** Long, 0.45 mtrs wide and 1.65 mtrs depth along the road for laying of optical fiber cable under Forest Division Ferozepur of forest land for the above mentioned proposal:-

1. Legal status of the forest land will remain unchanged.
2. The forest land will not be used for any other purpose.

3. No tree will be felled by the user agency.
4. Hon'ble Supreme Court of India vide order dated 28-3-08 in I.A No. 826 in 566 in W.P.(C) 202 of 1995 has fully exempted NPV provided: (a) no felling of trees is involved; and (b) the areas fall outside National Park/Wildlife Sanctuary.
5. User Agency has given Undertaking of Bank Guarantee to DFO, Ferozepur.
6. The Optical Fiber Cable will be laid along the road within the existing right of way and close to the outermost edge of the forest land. The dug out land shall be restored by the User Agency and the same shall be made good immediately after the approved operation.
7. User agency shall obtain the Environment Clearance under prevailing Acts/Rules/Guidelines, if applicable.
8. This approval is subject to the clearance of the proposal under relevant local Acts/Rules/Court's Rulings/instructions etc. as applicable.
9. The User Agency shall seek prior permission from the DFO, Ferozepur for carrying out any maintenance operation.
10. The User Agency shall abide by any other condition (s) that may be imposed by this Department in the interest of afforestation and protection of environment.
11. The State Forest Department may revoke/suspend this approval, if any of the above conditions is not satisfactorily fulfilled by the User Agency.
12. An undertaking is signed by the User Agency for abiding by all the aforesaid conditions.
13. If any other NOC is necessary under any Act/Rules/Guidelines etc. from other Departments, the user agency should obtain the same before the commencement of laying of Cable.
14. CF, Ferozepur Circle, Ferozepur /DFO Ferozepur shall ensure fulfillment of the above conditions.
15. This approval is granted subject to the condition that there is no court case pending in any court pertaining to the land or trees in the present FCA case. Any legal liability arising out of such case; if any, will be the sole responsibility of the land owning Department.
