Madam,

Pursuant to the Stage I (In Principle) approval accorded for the aforesaid project proposal, the User Agency has complied to all conditions by transferring fund of Compensatory levies and furnished the requisite documents, which are as follows :-

2	The User Agency shall transfer online, the Net Present Value (NPV) for the 0.0083 ha of the forest land being diverted under this proposal, as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters no. 5/1/1998-FC(Pt. II) dated 08/09/2003 as well as letter No.5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard. The requisite funds shall be transferred through online portal into the CAMPA account of the State concerned.	Complied and deposited Rs. 5,453.00 through NEFT/RTGS Challan.

2	Compensatory Afforestation shall be taken up by the Forest Department over <b>0.0166 ha</b> equivalent degraded forest land (Radang Khamsal PF of Ranipool Range under East Territorial Forest Division of Sikkim at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.	Noted
3	Additional amount of NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the user agency. 4	The User Agency shall restrict the felling of trees to minimum number in the diverted forest land the trees shall be felled under the strict supervision of the Forest Department and the cost of the felling of trees shall be deposited by the user agency with the State Forest Department	Noted
