It is submitted that the Government vide reference 9th cited have **accorded in-principle (Stage-I) approval** for “diversion of forest land to an extent of **0.5873 ha** in WLM Eturunagaram forest division of Mulugu District for laying of Optical Fiber Cable along the road and within the existing Right of Way for

execution of T-Fiber Project in favour of M/s.Telangana Fiber Grid Corporation Limited, Hyderabad."

The above orders have been communicated to all the concerned officers vide reference 10th cited with instructions to submit condition-wise compliance report as per the conditions stipulated therein.

Accordingly, the CCF/Conservator of Forests, Kaleshwaram circle has obtained condition-wise compliance report from the User Agency and the District Forest Officer, Mulugu and submitted together with its enclosures vide reference 13th cited. The copies of reference 13th cited together with its enclosures **in duplicate** are enclosed herewith. **The condition-wise compliance report is reproduced with remarks as follows:**

Vide reference 13th cited, the CCF/Conservator of Forests, Kaleshwaram Circle have obtained condition-wise compliance report from the User Agency and District Forest Officer, Mulugu district have submitted together with its enclosures to this office. Further, the CCF/Conservator of Forests, Kaleshwaram has informed that the User Agency has deposited the compensatory levies into the respective accounts. **The User Agency (M/s. Telangana Fiber Grid Corporation Limited) vide reference 12th cited has informed that all the compensatory levies have been paid and the compliance on Stage-I conditions have been submitted by them to District Forest Officer, Mulugu and requested this office to kindly accord working permission for laying of Optical Fiber Cable for the above-mentioned project.** The details of the amounts deposited are as follows:

Further, with regard to issue of working permission, it is informed that as per the clarification issued in reference 9th cited on the applicability of the Forest(Conservation)Rules,2022 issued in reference 8th cited that "Provisions of Forest (Conservation) Rules, 2003 shall apply to the proposals submitted online through PARIVESH Portal and which have been accepted by the

Nodal Officer before 28.06.2022.” In the instant case, the proposals have already been accepted by the Nodal Officer/ PCCF(HoFF) and the Stage-I approval has been granted. Hence, the guidelines issued in reference 1st cited in the form of Handbook and amendments issued therein and issued till that time are applicable. At Para 11.2 of the Handbook by the **Ministry in F.No.5-2/2017-FC, Dt.28.03.2019**, and amendments issued therein and the guidelines issued therein (reference 1st cited) and the guidelines issued in **F.No.11-306/2014-FC (pt), Dt.28.08.2015** detailed procedure about grant of permission for tree cutting and commencement of work of a linear project in forest land (*such as laying of new roads, widening of existing highways, transmission lines, water supply lines, optic fiber cabling, railway lines etc., in which the in-principle approval under the Forest (Conservation) Act, 1980 is accorded*) for a period of one year is given to facilitate speedy execution of projects. Such orders shall be passed only after full realization of funds for compensatory afforestation, Net Present Value (NPV), wildlife conservation plan, plantation of dwarf species of medicinal plants, and all such other compensatory levies, specified in the Stage-I (in-principle) approval from the UA, and where ever applicable, transfer and mutation of non-forest/ revenue forest land in favour of State Forest Department.

Further, the **State Government of Telangana** vide **Memo.No.3983/For.I(1)/2016-2, Dated.15.10.2016** has authorized the **Principal Chief Conservator of Forests (Head of Forest Force)** to issue **working permission to the User Agency**, for tree cutting and commencement of work of linear projects, for a period of one year, subject to the conditions stipulated in the in-principle approval and their compliance, in accordance with the guidelines issued by **GoI, MoEF & CC, New Delhi in F.No.11-306/2014-FC(pt.) dt.28.08.2015**.

In view of the above, the request of the User Agency (**M/s. Telangana Fiber Grid Corporation Limited**) vide reference 12th cited has been examined in exercise of the powers delegated to the undersigned in **Govt. Memo.No.3983/For.I(1)/2016-2, Dated.15.10.2016** and with reference to the reference 1st, 8th and 9th cited, the **“working permission is hereby accorded in favour of M/s. Telangana Fiber Grid Corporation Limited for commencement of works in the forest land proposed to be diverted from the date of entering into agreement with the District Forest Officer, Mulugu district for a period of one year,”** subject to the following conditions:

1. M/s. Telangana Fiber Grid Corporation Limited i.e., **User Agency** shall report to the District Forest Officer, Mulugu having jurisdiction over the proposed forest area; and obtain further permission from him before starting the work. The works should be carried out under the supervision of the concerned Forest Divisional Officer/District Forest Officer.
2. The Authorized Signatory of User Agency shall enter into an agreement with the District Forest Officer, Mulugu/concerned Circle head agreeing to perform all conditions as stipulated in Stage-I approval orders and also MoEF&CC, GoI, New

Delhi guidelines issued in **F.No.11-306/2014-FC(pt), dt.28.08.2015** and also that stipulated in covering letters, Part-II to V, and obtain further permission for commencement of the works.

3. The User Agency shall publish the working permission now granted in verbatim language along with the conditions and safe-guards imposed by the Central Government in Stage-I approval in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes **(C.No.vii of F.No.11-306/2014-FC(pt) dt: 28.08.2015)**.
4. The copies of the Forest Clearance and the working permission should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the Second Party in addition to the relevant offices of the Government who in turn has to display the same in 30 days. **(C.No.vii of F.No.11-306/2014-FC(pt) dt:28.08.2015)**.
5. The Forest Department shall dispose all the appeals filed against the order of Deemed Permission issued by the PCCF (HoFF). **(C.No.v & vi of F.No.11-306/2014-FC (pt) dt:28.08.2015)**.
6. The User Agency shall agree, bind and undertake to comply to any other conditions that may be imposed from time to time by the MoEF & CC, GoI/State Government and Principal Chief Conservator of Forests (Head of Forest Force) in the interest of Conservation, Protection & Development of forests, in addition to conditions imposed in Stage I (in-principle) approval.
7. The cable line shall be laid at least one meter below the ground level and the forest land shall be restored to its original state after laying the same.
8. No tree felling shall be carried out by the User Agency. No damage shall be caused to forest/wild life and to the environment.
9. The User Agency shall ensure that the length of the trench dug at a time does not exceed 500m. The trench should be filled up and compacted before digging next stretch of 500m. The User Agency shall make good any loss to forest/ environment.
10. Any other conditions imposed by the concerned Circle head, District Forest Officer/Forest Divisional Officer during execution of work in the interest of protection of Forests shall be carried out at the project cost.
11. The works should be carried out without any scope for violations under various rules and guidelines envisaged under Forest (Conservation) Act, 1980 and Wildlife (Protection) Act, 1972 and other relevant guidelines and Rules in force.
12. The working permission issued is valid upto a period of one year from the date of entering into an agreement with the District Forest Officer, Mulugu district. In case, if the User Agency fails to complete the work within the stipulated time, for further extension of working permission, they have to approach the undersigned.

The District Forest Officer, Mulugu district is requested to enter into agreement with User Agency for working permission and permitted to take up Construction of boundary pillars from the amount deposited in the CA-PD account of DFO/FDO soon after entering into agreement for working permission. The works shall be included in APO 2022-23 for CA-PD account and should be reported in MPR of CA-PD account.

In the letter 2nd read above, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has submitted a proposal under section-2 of Forest (Conservation) Act, 1980, for diversion of **0.5873 ha** of Forest Land in WLM Eturunagaram division of Mulugu District for Laying of Optical Fibre Cable along the road within the existing Right of way for execution of T-Fibre project in favour of M/s.Telangana Fibre Grid Corporation Limited.

2. The proposal has been examined with reference to the guidelines issued by the Government of India in the letter 1st read above.

3. Government after careful examination of the proposal and in exercise of the powers delegated to State Government in the guidelines issued by Government of India in the letter 1st read above, hereby accord **in-principle (Stage.I) approval** for diversion of **0.5873 ha** of Forest Land in WLM Eturunagaram division of Mulugu District for Laying of Optical Fibre Cable along the road within the existing Right of way for execution of T-Fibre project in favour of M/s.Telangana Fibre Grid Corporation Limited, subject to compliance of the following conditions:-

- i. The legal status of the forest land shall remain unchanged;


