It is submitted that the Gol, MoEF&CC, Sub-Office Hyderabad (RO Chennai) vide reference 11th cited have **accorded in-principle (Stage-I) approval** for "diversion of **3.8561 ha** of forest land **(FP/TG/OFC/145010/2021)** in Asifabad division falling in various RFs of Asifabad division in Komarambheem-Asifabad District for laying of Optical Fiber Cable in favour of M/s.Telangana Fiber Grid Corporation Limited." The above orders have been communicated to all the concerned officers vide reference 12th cited with

instructions to submit condition-wise compliance report as per the conditions stipulated therein.

Accordingly, the Conservator of Forests & Field Director Project Tiger, Kawal Tiger Reserve Circle, HQ Mancherla has forwarded the compliance report obtained from the District Forest Officer, Komaram Bheem Asifabad and the User Agency with its enclosures vide reference 15th cited. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purposes in verbatim along with the condition(s) and safeguards imposed by the Central Government in two widely circulated daily news paper i.e., one is vernacular language and the other in English.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in-turn has to display the same for 30 days from the date of receipt of this reference.
3. The User Agency to take necessary action in submission of RoFR certificate obtained from the District Collector as stipulated in the Stage-I condition.
4. After making necessary payment and fulfilling all the conditions, upload the compliance report on the Ministry's portal against the subject proposal in-order to enable the District Forest Officer to further process the proposal.

The District Forest Officer, Kumrambheem-Asifabad district is specifically directed to obtain and submit **condition-wise compliance report with all the documentary evidence and upload the same online for obtaining Stage-II (final) approval** from the competent authority.

The transfer of forest land to User Agency shall not be affected prior to the issue of final approval (or) working permission, whichever is earlier.
