It is submitted that the Government vide reference 6<sup>th</sup> cited have **accorded in-principle (Stage-I) approval** for "diversion of **0.3548 ha** of forest land to an extent of **0.3548 ha** from Mahabubnagar-Wanaparthi-Pebbair passing through Wanaparthi RF of Wanaparthi forest division of Gadwal-Wanaparthi district for laying of Optical Fiber Cable in favour of M/s.Bharti Airtel Limited (earlier known as M/s. Telesonic Networks Limited, Hyderabad)." The above orders have been communicated to all the concerned officers vide reference 7<sup>th</sup> cited with instructions to submit condition-wise compliance report as per the conditions stipulated therein.

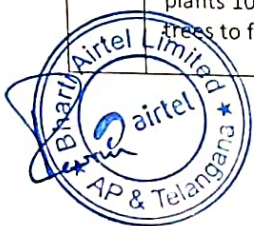
