Stage-1 approval for the subject project was accorded by the IRO, MoEF&CC, GoI, Hyderabad vide ref 1st cited, with certain conditions stipulated therein.

In compliance to the conditions stipulated in the Stage-I approval, User Agency has deposited an amount of Rs. **2,54,57,265/-** through NEFT/ RTGS Challan generated from parivesh portal of MoEFCC as per the demand notice issued by the District Forest Officer and the same is reflected as "Paid" in the Ministry Portal, against File No FP/TG/ROAD/138479/2021.

Further, the UA has deposited an amount of Rs. 18,50,000/- towards construction of boundary pillars and an amount of Rs.2,40,000/- Speed regulating signages and speed breakers shall be erected along the road at regular intervals in the Forest Area into the PD account of DFO.

The Chief Conservator of Forests, Rajanna Circle, Siddipet vide ref 10th & 12th cited and District Forest Officer, Rajanna Sircilla & Karimnagar vide 13th cited has submitted condition-wise compliance for further necessary action.

The condition-wise compliance report is reproduced with remarks as follows:

The State Forest Department shall carry out compensatory Afforestation in the identified degraded forest land over an extent of 8.50 ha. in compartment No 172/1 of Konaraopet East Beat of Chandurthi Mallial Range and over an equivalent Non-Forest Land (7.7436 Ha) identified for Compensatory Afforestation in Sy. No I16/1/3 and/or 1 17/1/2 situated in Kondapur village of Konaraopct Mandal, Rajanna Siricilla District at the cost of the User Agency. Revised CA scheme for the equivalent NFL and identified DFL area may be prepared by the SFD as per the prevailing norms.	As detailed above User Agency has deposited an amount of Rs. 2,54,57,265/- through NEFT/ RTGS Challan generated from parivesh portal of MoEFCC as per the demand notice issued by the District Forest Officer including the cost towards CA, NPV and others and the same is reflected as "Paid" in the Ministry Portal, against File No FP/TG/ROAD/138479/2021. The State Government shall charge the Net Present Value of the diverted forest land measuring 7.7436 ha from the User Agency as per the orders of the Hon'ble Supreme Court dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA Nos.826 in 566 with related LA's in Writ Petition (Civil) No.202/1995 and revised NPV as per the Ministry's guideline No.5-3/2011 FC(Vol-1) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022. (viii)	Construction of culverts/ bridges, if any, over the natural streams/rivers/canals shall be done in such a manner that it does not hamper or deviate the natural course of water, does not give rise to water-logging, and also does not hamper movement of wild animals.	Undertaking to this effect furnished by the User Agency is enclosed
(ix)	Roadside cuttings and fillings which require engineering support shall be provided as per the technical requirement within the forest area to be diverted in consultation with the DFO concerned.	The User Agency has informed that the Roadside cuttings and fillings will be done as per the technical requirement
(ix)	The dugout material/overburden shall be dumped outside the forest area. Storage of any material shall not be done in the forest area.	Undertaking to this effect furnished by the User Agency is enclosed
(xi)	The User Agency shall fell the trees as per the revised enumeration list (266 numbers of trees only) and endeavor to avoid felling of trees existing on the forest land proposed to be utilized to the extent possible. Wherever necessary. Felling shall be carried out under the strict supervision of the DFO/FDO concerned. Wherever feasible the State Forest Department shall carry out translocation of trees instead of resorting to felling, at the cost of the User Agency. (xii)	Speed regulating signage's and speed breakers shall be erected along the road at regular intervals in the Forest Area by the User Agency. (xiv)	The User Agency shall provide fire wood preferably alternate fuel to labourers working at the site to avoid damage/tree felling and no labour camp shall be established inside the forest area.	Undertaking to this effect furnished by the User Agency is enclosed
(xv)	It shall be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not cause any damage to the nearby forest flora and fauna.	Undertaking to this effect furnished by the User Agency is enclosed

(xvi)	The total forest area utilized for the project shall not exceed 7.7436 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.
