- 7. Further a series of notices was issued by the Forest Divisional Officer, Bhupalpally Rc, No. 167/2018/TA, dt. 17.06.2019 & 21.08.2019 to the Executive Engineer, R&B Nh, Warangal and requested to get permissin from the competent authority for execution of the road work.


