The Chief Conservator of Forests (CCF), Medak Circle, Medak vide reference 17<sup>h</sup> and 21<sup>st</sup> cited has submitted condition-wise compliance report on the Stage-I approval accorded by the MoEF&CC, GoI, Hyderabad for the subject project vide 2<sup>nd</sup> cited on the subject proposal.

**The condition-wise compliance report is reproduced with remarks as follows:**

**Rule position:**

**A. On collection of NPV as per revised rates.**

As per the revised NPV rates and clarification communicated by the MoEF&CC, GoI, New Delhi on collection of NPV on 06.01.2022 & 22.03.2022. Revised NPV rates are applicable **for all proposals**,

- I. New rates will be applicable on all the proposals that have been granted Stage-I / in-principle approval after 06.01.2022,
- II. The new rates will also be applicable on all the cases that were granted Stage-I / in-principle approval prior to 06.01.2022 and even after lapse of 5 years, the Stage-II / final approval is not granted, due to non-submission of complete compliance of the conditions stipulated in the Stage-I / in-principle approval.

This proposal falls under category (ii). **Hence, the Govt. while considering the proposal for Stage-II approval is requested to stipulate for collection of NPV as per the revised rates from the User Agency.**

**B. Identification of equivalent non-forest land and according General approval:**

As per the guidelines issued in GoI, MoEF & CC, New Delhi, File No.FC-11/160/2019-FC, Dt.23.06.2021, **the State Government can grant final (stage-II) approval for the projects where the State Government has accorded Stage I approval prior to 31.12.2019 as per the provisions contained in Para 4.4 read with 4.1 of handbook for LWE districts (valid upto 31.12.2020).** At the time of granting Stage-I approval as per Para 4.4, erstwhile Medak District was LWE district, now Medak is not a LWE district. The Para 4.4 has been withdrawn in File No.11-09/1998FC(PT)-Part(1), Dt.10.05.2021.

**Further it is submitted that the Stage-I approval is accorded by State Govt. on 25.05.2016 and five years validity is lapsed on 24.05.2021.** The compliance report to be submitted to Govt. is pending for want of payment of cost towards construction of boundary pillars, which is paid in this month.



Further, it is submitted that the MoEF&CC, GoI, New Delhi vide ref 11<sup>th</sup> cited has communicated the list of Stage-I approval accorded and compliance pending with the State Govt. and **requested the following:**

- a. the State Govt. / UT Administrations to apprise this Ministry whether they are interested to continue these projects within 45 days from the date of issue of this letter.
- b. Further, it has been informed that if the response of the State Govt. in this regard is not received to the Ministry within the Stipulated time, the process of summary revocation of the proposal granted Stage-I approval.

**The subject project is mentioned at Sl.No.1682.** As per the time-line fixed by the MoEF&CC, GoI, New Delhi the compliance report to be submitted to the IRO by 10.08.2022.

**In view of the above compliance report is submitted with for according/obtaining the final (Stage-II) approval for the subject project duly obtaining clarification on Point (a) and (c) above from the IRO, MoEF&CC, GoI, Hyderabad.**



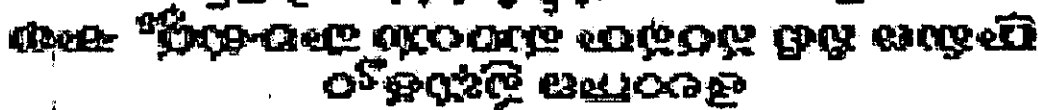
