Kind attention is invited to the references cited.

It is submitted that, the Government of India, Ministry of Environment, Forests & Climate Change, Regional Office (South Eastern Zone), Chennai in the reference 7th cited has accorded in-principle (**Stage-I**) approval, for "Diversion of **22.258 ha** of forest land in erstwhile Warangal (N) and WLM Warangal Divisions presently Mulugu, Tadvi and WLM Eturnagarm Divisions for laying of pipe line and construction of structures in **Segment-20/3 (Eturunagaram)** for providing safe drinking water under TDWS Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Warangal" **subject to certain conditions stipulated therein**; which has been communicated vide reference 8th cited by the Principal Chief Conservator of Forests (HoFF) to the Superintending Engineer, TDWSP (RWS&S) Circle, Warangal (user agency) and concerned Conservator of Forests/ District Forest Officer/ Forest Divisional Officers, for taking further necessary action.

Accordingly, the Conservator of Forests, Warangal has furnished the condition wise compliance report which is obtained from the District Forest Officer, Mulugu; Forest Divisional Officers, Mulugu WLM Eturnagaram, Tadvai Divisions and User Agency and submitted to this office vide reference 9th cited. A copy of reference 9th cited together with its enclosures **in triplicate** is enclosed herewith.
