I wish to inform that, the Government of India, MOEF & CC, RO, Chennai  
vide reference 3<sup>rd</sup> cited has conveyed the In-Principle approval (Stage-I) under  
Section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for the

above proposal. The Divisional Engineer, OFC Projects, BSNL, Madurai has uploaded the compliance report for the conditions stipulated by the Government of India in Stage-I approval.

The State Government during recommendation, stated in condition No.3, the User Agency has to pay the cost of raising Compensatory Afforestation / maintenance of plantation, etc., as fixed by the Forest Department. As per the Van (Sanrakshan Evam Samvardhan) Rules, 2023, Rule No. 13 (5) (b), diversion of forest land upto one hectare, cost of plantation for minimum number of 100 plants shall be levied from the User Agency towards Compensatory Afforestation. Based on this, the Compensatory Levies demand, for the cost of raising the CA plantation of 100 Nos in DFL area and maintaining 10 years for Rs.1,55,273/- was paid by the User Agency on 22.10.2024, which is reflected in the Parivesh 1.0 portal.

The compliance report furnished by the user agency along with connected undertakings / documents and report of the Conservator of Forests & Field Director, SMTR, Madurai and the District Forest Officer, Theni are forwarded in the PARIVESH Portal for further action.

I request that the compliance report may be accepted and obtained Stage-II final approval from the competent authority for diversion of 0.045 ha of forest land passing through Valkaradu RF, Paramasivankovil Karadu RL, Ammapuram Bit-II RF and Pinnathevanpatti RL for laying of underground OFC along existing road between Theni - Batlagundu through rural areas at Theni district in favour of Divisional Engineer, OFC Projects, BSNL, Madurai for a period of 20 years.

It is submitted that in-Principal approval (Stage-I) was accorded under section 2 of Van (Sanrakshan E�am Samvardhan), Adhiniyam, 1980 [Previously called Forest (Conservation) Act, 1980] for diversion of Forest land in Valkaradu Reserve Forest, Paramasivan Kovil Karadu Reserve Land, Ammapuram Bit-II Reserve Forest and Pinnathevanpatti Reserve Land of Theni Forest Division to a total length of 1800 Meter and width of 0.25 Meter and in depth 2.00 Meter totaling to an area of 0.045 Hectare for laying of underground optical fiber cable along road side for providing Mobile Arasu Cable, Broadband Connectivity between Theni-Batlagundu through rural areas at Theni District has been approved by the Government of India vide reference 8<sup>th</sup> cited.
