I wish to inform that, the User Agency i.e., M/s. Reliance Jio Infocomm Ltd., SCO, Mylapore, Chennai has uploaded the Compliance report for the conditions stipulated by the Government of India in Stage I approval for diversion of forest land of 0.033 ha of forest land for laying OFC on the boundary of the
