I wish to furnish herewith the Compliance report on Stage I approval accorded by the Government vide reference 2nd cited for the diversion of 0.0768 ha of forest land for erection of 11 KV feeder (HT) EB posts from Ayyur to Pukkuzhi Village via Silambur across Kanguli Reserved Forests and Tirukkonam Reserved Forests in Ariyalur District.




Since the conditions stipulated in the Government letter 2nd cited have been full filled by the User Agency, I request that Stage - II final approval for diversion of 0.0768 ha of forest land for erection of 11 KV feeder (HT) EB posts from Ayyur to Pukkuzhi Village via Silambur across Kanguli Reserved Forests and Tirukkonam Reserved Forests in Ariyalur District in favour of TANGEDCO, Ariyalur for a period of 20 years may be issued and communicated early.
