I furnish herewith the Compliance report on Stage I in-Principle approval accorded for diversion of 0.389 ha of forest land in Gummanur Reserve forest area in Dharmapuri Forest Division for four laning of Thorapalli Agraharam-Jittandahalli section of new NH-844 from km 23+350 to km 60+100 (design chainage) under Bharatmala Pariyojana Phase I (National corridor) in Hybrid Annuity by NHAI, Krishnagiri in favour of General Manager, Project Implementing Unit-Krishnagiri, National Highways Authority of India, Krishnagiri as follows.

Hon'ble Supreme Court of India judgment dated 11.01.2023 in I.A Nos 168328/2022 and 168313/2022 and I.A Nos. 191583/2022, have directed that the order requiring permission of this Court for felling of trees in all forest areas in respect of any road projects initiated by NHAI or any other instrumentality of the State, which involves cutting of up to 500 trees is recalled subject to following conditions.



i) Such felling shall be done only after necessary approval under FCA 1980, Forest Conservation Rule 2022, Compensatory Afforestation Fund Act 2016 and Compensatory Afforestation Fund Rules 2018 are obtained from the competent authority under the said enactments.

ii) The projects would be permitted only after the concurrence of the Integrated Regional Office (IRO), Chennai.


iii) While granting such permission, the authorities also should provide for necessary mitigation measures for ensuring free flow of the wildlife from one part of the forest to the other whenever such forest is divided by road.

Hence concurrence of the Integrated Regional Office, Chennai is required for this project.

I request that, Concurrence of the Integrated Regional Office, MoEFCC, Chennai may be obtained for this project and Stage - II final approval of Government may be issued for the diversion of 0.389 ha of forest land in Gummanur Reserve forest area in Dharmapuri Forest Division for four laning of Thorapalli Agraharam-Jittandahalli section of new NH-844 from km 23+350 to km 60+100 (design chainage) under Bharatmala Pariyojana Phase I (National corridor) in Hybrid Annuity by NHAI, Krishnagiri in favour of General Manager, Project Implementing Unit-Krishnagiri, National Highways Authority of India, Krishnagiri for a period of 25 years
