<p>Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.</p>	<p>: As the proposed project is taking the barest minimum area of Reserve Forest and there is no other alternative available.</p> <p>Thus, the diversion area of 0.521 Ha for Construction of BT Road from Kamana to Sarkepalli (via Patakuda, Laxmipur & Lainguda villages) of Wankidi Mandal with reduced width of 5.50 meters over a length of 947 meters, which is falling in Garaplet (Part) Reserve Forest in Asifabad Forest Division, is recommended considering all the aspects mentioned in the proposal and field conditions.</p>
