The User Agency is responsible for safe guarding the adjoining flora and fauna in the surrounding area.</li> <li>2. The NPV value as applicable shall be paid by the user agency upon stage-1 approval for further process of the proposal.</li> <li>3. The User Agency shall deposit an amount of Rs. 15.866 lakhs towards CA.</li> <li>4. The user Agency shall deposit an amount of Rs. 53.95 lakhs(2x1079 =2158 cmt @ 2500/ rmt) towards cost of chainlink fencing on either side of the diverted area.</li> <li>5. The user agency shall deposit an amount of Rs.3.380 lakhs towards cost of extraction of tree growth.</li> </ol>
