MEMORANDUM:-

This department has given an "in principle "approval for Diversion of **0.49 ha.** protected forest land for ground level drinking water Tank in Mirzapur land Ta.Bhuj, Kachchh in favour of Chief Officer, Bhuj Nagar Sewa Sadan, Bhuj, vide letter referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs.4,49,667/- towards cost of CA + Rs.2,14,620/- towards the cost of NPV through NEFT/RTGS, dt.16.09.2020 in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) & Processing Fees and Registration fee Rs.7000/- is deposited in 8782 Forest Remittance referred at Sr. No. (2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- 1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. Compensatory Afforestation is proposed at **1.00 ha** degraded forest land at S. No.554/ pt., Village-Nirona, Tal.Nakhtrana, Dist. Kachchh.. CA shall be of mix of local indigenous species. Monoculture of any species shall be avoided. CA will be maintained for 10 years.
- 4. The User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
- 5. User Agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.

- 6. The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 7. The user agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar.
- 8. The additional conditions under chapter-5 of Forest (Conservation) Act, 1980 shall be applicable to this proposal as the Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015. The user agency shall be bound to comply additional condition as per the aforementioned resolution. The project authority has submitted undertakings for the same.
- 9. Any other condition, which the Nodal officer (FCA) may stipulate from time to time. By order and in the name of the Governor of Gujarat.
