CERTIFICATE

1. It is certified that the process for ascertainment of forest rights/ claims under Scheduled Tribes and other Forest Dwellers Act, 2006 over the 3.65 Hectare (2.33 Hectare of forest land and 1.32 Hectare USF Area) required for construction of Rassing HEP 12 MW being developed by M/S Gekam Power Private Limited has been completed. Further, fishing rights and collection of traditional forestry commodities of the affected persons over the river bed area shall be continued. Therefore, the process for ascertainment of Forest rights/claims of the individual/ communities under FRA over the 3.65 Hectare of Land have been completed. The resolution passed by the Gram Sabha of Leporiang Panchayat under Leporiang Circle was thoroughly examined and verified by the Divisional Level Committee (DLC) and found in order, same enclosed herewith.
2. It is also certified that the proposal for diversion of 3.65 Hectare (2.33 Hectare of forest land and 1.32 Hectare USF Area) for construction of Rassing HEP (12 MW) falling within the Rassing and Langruk village of Leporiang Panchayat under Leporiang Circle of Sagalee Sub Division of Papum Pare District were put forward before the Zilla Panchayat/ Gram Sabha of Concerned Panchayat. It is further certified that the full details of the Rassing HEP (12 MW) proposal and process for ascertainment of rights/ claims of Communities/ individuals over 3.65 Hectare (2.33 Hectare of forest land and 1.32 Hectare USF Area) for diversion was described to Villagers in the local dialect/ Vernacular language. Detailed discussion regarding forest rights over 3.65 Hectare of land falling within the jurisdiction concerned Gram Sabha of Leporiang under Leporiang Circle was carried out in vernacular language. The Gram Sabha meeting were conducted in free, open and fair manner and as per the provision of law.
3. It is certified that 3 (Three) Months notice period in the form of Public Notice was given to receive the claims, hence reasonable opportunity and sufficient time was provided to all interested individuals/ parties to put forward their views/ claims.
4. It is certified that more than 60% of the villagers of concerned affected village of Rassing and Langruk of Leporiang Panchayat under Leporiang Circle were present in the meeting and actively participated in the discussion and same was recorded in the resolution. The Gram Sabha meeting of the Leporiang panchayat under Leporiang Circle was conducted in a free, Open and fair manner with requisite quorum. All the villagers were given same opportunity to register their claims, if any. The Villagers of concerned Gram Panchayat have given their consent to the diversion of land for construction of Rassing HEP (12 MW).
5. It is certified that the Gram Sabha in its meeting has recognized the right under FRA, the rights of which would be settled by District Administration as per the Prevailing norms/ laws. Rights identified by the Gram Sabha are ownerships rights over the community land/ individual land with forest cover and traditional rights for collection use and disposal of minor forest produce over forestland. Further, it is resolved that fishing rights, if any effected people shall be continued. The details of recognized claims/ rights and persons are given with respective Gram Sabha. Further no appeal/ grievances have been filed against Gram Sabha resolution to the Deputy Commissioner within a stipulated time frame.
6. It is Certified No Other Traditional Forest Dwellers (OTFD) is present/ settled/ dwelling in the concerned Gram Sabha of Leporiang Panchayat under Leporiang Circle, Sagalee sub division of Papum Pare District of Arunachal Pradesh.
