No. FOR 240/CONS/2009/74.-In exercise of the powers conferred by section 3A of the Arunachal Pradesh Anchal Forest Reserve (Constitution and Maintenance) Act, 1975 (Act No. 1 of 1976) as amended by the Arunachal Pradesh Anchal and Village Forest Reserve (Constitution and Maintenance) Amendment Act, 1984 (Act No. 4 of 1984), the Governor of Arunachal Pradesh is pleased to propose to constitute the land described in the schedule hereunder as Village Forest Reserve (VFR).

The Governor, in exercise of the powers conferred by sub-section (1) (C) of Section 5 of the Assam Forest Regulation, 1891 (7 of 1891), is further pleased to appoint the Deputy Commissioner Dibang Valley District, Anini as the Forest Settlement Officer to inquire into and determine the existence, nature and extent of any right claim by, or alleged to exist in favour of any person in or over any land comprised within such limits; described in the said Schedule and any claim relating to the practice within such limits, of Jhum Cultivation, and to deal with the same as provided in Chapter II of the said Regulation.

The Governor is also pleased to appoint the Divisional Forest Officer, Anini Social Forestry Division, Anini to be the Forest Officer under sub-section (2) of section 5 of the said Regulation who shall assist the Forest Settlement Officer in the inquiry prescribed in Chapter II of the Assam Forest Regulation, 1891.

The Governor is further pleased to appoint the Secretary (GA), Government of Arunachal Pradesh to hear the appeals under section 15 of the said regulation.

Whereas, a site inspection for Mipi to Andrala road 0.00 km to 50.00 km (Proposal No. FP/AR/Road/148555/21) was done by Chief Conservator of Forests, Eastern Arunachal Circle, Tezu on 04.08.2022 along with OC, 62 RCC (GREF) and DFO Anini.

Whereas, during site inspection it was first detected that the earth cutting in the initial 2 km approximately had already been done over an approx. area of 4.80 Ha and the 1st violation was reported by CCF, Tezu.

Whereas, while performing duties as Range Officer, Anini Forest Range, Shri Kashok Solung FR, failed to maintain absolute integrity and devotion to duty by failing to report and stop this violation of FCA to his superior authority within reasonable time.

ARTICLE II

Whereas, again during a subsequent site visit on **14.09.2023** along with IRO Shillong, NO (FCA) Itanagar, CCF Tezu and Commander 752 TF (UA) etc, it was again detected that track improvement had been extended and was being carried out from already violated area of 2 km to ahead of existing 2.00 km to 8.00 km (6.00 km) over an approximate area of 5.10 Ha.

Whereas, in both the above cases, it is evident that the violations were neither detected nor reported by Shri Kashok Solung FR, RO Anini on his own to his superior authority as there was no reporting or efforts made to stop violation from his side and so Shri Kashok Solung FR, Range Forest Officer, Anini Forest Range displayed gross negligence to duty.

ARTICLE I

Whereas, the site of inspection of Proposal No. FP/AR/ROAD/148555/2021 "Diversion of 144 Ha for construction of 0.00 km to 50.00 km Mipi-Andrala road" for diversion of 144 Ha of forestland for construction of 0.00 km to 50.00 km Mipi-Andrala road by BRO, 62 RCC, C/o 99 APO was done by Chief Conservator of Forests, Eastern Arunachal Circle, Tezu on 04/08/2022 along with OC 62 RCC (GREF) and DFO Anini.

Whereas, during the inspection on 4.8.2022 it was found that the earth cutting in the initial 2 km approximately had already been done. On enquiry from BRO, it was informed that Army had done the earth cutting during the year 2020. A letter dtd. 18/05/2022 of DLR&SO Dibang Valley addressed to BRO Anini along with the representation of 3 (three) clan of Mipi Circle was produced in support of the claim by the UA (copy enclosed). The said representation mentioned that the villagers of threes clans of Mipi had given an NOC dtd. 28/06/2020 to Indian Army for construction of operational track/ road from Mipi to Andrala Omkar (length 54 km with formation cutting of 12 mtrs). The track/ road was later handed over to BRO in its present form somewhere during Feb/2022.

Whereas, an explanation of Shri Kashok Solung FR, RO Anini was called by DFO Anini vide his No. ASFD/BRTF/M-A/27/2016/PT-I/ dt.31.10.2022. Shri Kashok Solung FR, RO Anini in his reply vide No. ASFR/ 04/ 2008/ 590 dt. 1.11.2022 addressed to DFO Anini informed that there was pandemic in 2020-21 and so there was restriction on movement. It was stated in the explanation that during this pandemic situation, the Army, which had manpower and machinery, started formation cutting on Mipi Andrala road which could not be detected by him in time as and he could not visit the place of violation in time due to restriction on movement.

Whereas, an Offence Report No. ASFR 11 of 2022 dt. 5.11.2022 against CO ETF 3 Corps, PIN 908503, C/o 99 APO and OC 62 RCC (GREF) PIN 930062, C/o 99 APO was later drawn by Shri Kashok Solung FR, Range Forest Officer, Anini Forest Range on 5.11.2022 against above violation detected on 4.8.2022.



ARTICLE II

Whereas, during a subsequent site visit on **14.09.2023** along with IRO Shillong, NO (FCA) Itanagar, CCF Tezu and Commander 752 TF (UA) etc, it was again detected that track improvement had been extended and was being carried out by OC 62 RCC (GREF), PIN 930062, C/o 99 APO from already violated area of 2 km to ahead of existing 2.00 km point to 8.00 km (6.00 km) over an approximate area of 5.10 Ha.

Whereas, in both above cases, there was no reporting of violations done by Shri Kashok Solung FR, Range Forest Officer, Anini Forest Range from his side and it is evident that the violations were neither detected nor reported by Shri Kashok Solung FR, RO Anini on his own.

Whereas an Offence Report No. AFR 01 of 2023 dt. 15.9.2023 against OC 62 RCC (GREF) PIN 930062, C/o 99 APO was later drawn by Shri Kashok Solung FR, Range Forest Officer, Anini Forest Range on 15.09.2023 against above violation detected on 14.9.2023.

Whereas, from the above, it is clear that the breaking up of forestland took place during the tenure of Shri Kashok Solung FR, being Range Forest Officer, Anini Forest Range and no reporting was done by him within reasonable time on his own which displayed gross negligence and carelessness on his part by failing to fulfill his duty as guardian of forest areas under Anini Forest Range thus unbecoming of a government officer.

Then Proposal No. FP/AR/ROAD/148555/2021: Mipi-Andrala ICBR for diversion of 144.0 Ha of Forest Land for the construction of 50.0 Km Mipi-Andrala ICB Road by 62 RCC (GREF). Out of the total 144.0 Ha required for diversion, 103.95 Ha falls inside Dibang WLS. The initial stretch of 0 - 13 km of Mipi Do to Andrala road passes through USF area after which it enters Dibang WLS and runs through it for the remaining 13 - 50 km stretch.

During site inspection on 14.9.2023 with DDGF (Central), The DIGF (Central), APCCF & NO, FCA, Commandant TF Roing and CCF, Tezu, along with DFO Anini, RFO Anini and their staff, violation was noticed beyond 2 km point of Mipi-Andrala road was already under construction.

Breaking the Forest open, cutting of Forests, formation cutting, construction of culverts etc. before getting necessary clearance/ approval from competent authorities amounts to violation of FCA 1980, Forest Conservation Rules 2019 (Sec.1.21(ii)). The work was started after application uploaded but before obtaining clearance which is a gross violation of the FCA-1980. So O/R and violation report in format is drawn against the user agency.

(i) OC 62 RCC (GREF), PIN 930062 C/o 99 APO for $(3000m \times 10m) + (3000m \times 7m) = 3.0 ha + 2.1 ha$. Total area affected = 5.10 ha.

100% penalty on NPV is leviable against the stretch of 6.0 km of forest land cleared (from 2.0 km to 8.0 km), since the proposed road is Defence Road (ICBR itself says that is a defence road) and is not a public utility road.

Hence, as per 1.21 (ii) the royalty on NPV= Rs.1005210/ha x 5.10 ha = 51,26,571.00 + 12% interest till deposit is made.



Please refer my inspection on 4.8.2022 with you of the above proposal for diversion of 144 Ha of forest land for construction of Greenfield Mipi – Andrala 0 - 50 km of road to NHSL specification.

During the inspection it was seen that earth cutting on the initial about 2 Km road had already been done. On enquiry you informed that the earth cutting had already been started by the Army in 2020 and probably continued till recently against Mipi- Andrala operational foot-track being implemented by them. It was also informed by you that you were handed over this stretch of road in the same form by the Army just in Feb, 2022. You also produced 2 letters dt. 18.5.2022 and dt. 20.11.2021 in support of your claim.

It is seen from office records that at least three almost identical proposals for operational foot track by army, foot track by CPWD/ NHIDCL and road by BRO between Mipi-Andrala is under correspondence. It has also been seen that at present you have started resource mobilization of man and machinery on the initial 2 km approx stretch of Mipi Andrala road where earth cutting had already been done. The start of work on Mipi – Andrala foot track by Army or the road by BRO before formal approval is a violation of Forest (Conservation) Act, 1980 as per law and AFR, 1891.

You have also informed me verbally that there was a pressure from army authorities to hasten the project of construction of Mipi Andral 0.00 km to 50.0 km for which army was even contemplating to airlift man and machineries by chopper to inside the forest to start the work from the other side also. This also shows the urgency of Army Authorities/ MoD to the seriousness on the issue of Chinese aggression being given by them.

Though the need for immediate construction of Mipi Andrala operational foot track or the road to NHSL specification is well understood due to its strategic importance in movement of troops for safe guarding the territorial integrity of India by armed forces but I am constrained to direct you to refrain from starting any works of earth cutting or widening of the already broken up land or any place further ahead in the WLS before formal approval under FCA, 1980 as per rules in vogue.

In case you so desire, you may approach the NO (FCA) Itanagar for permission to start the work citing justification of extreme emergent circumstances of safe guarding the territorial integrity of the Country and await his decision on the matter.

REPLY TO NOTICE UNDER SECTION 3A AND 3B OF THE VAN (SANRAKSHAN EVAM SAMVARDHAN) ADHINIYAM, 1980 READ WITH RULE 15(3) OF THE VAN SANRAKSHAN EVAM SAMVARDHAN) RULES, 2023

1. Please ref your Office letter F.No.3ANA/182/2023/Ghy/5292-93 dated 05 Mar 2024.

2. The emergence of threats of incursion and capture of our integral territory along the LAC in Arunachal Pradesh by our adversary gained disproportionate and heightened risk especially in view of the incidents in Northern Parts along the LAC. To counter these threats the Govt of India also declared "**Op Snow Leopard**" which enhanced our vigil and alertness necessitating reinforcement and redeployment of troops all along the LAC.

3. The enhanced redeployment of our Army and the Indo Tibetan Border Police (ITBP) at numerous posts in the forward areas along the Line of Actual Control (LAC) necessitated the conception, planning and construction of operational tracks and lines of communication to sustain these troops along the LAC. The road Mipi-Andrala was also conceived and prioritized **as a high priority corridor** by the Directorate General of Military Operations (DGMO), Integrated Headquarter of Ministry of Defense (Army) for the movement of troops and their sustenance in this area which was appreciated as a very high risk area for capture by the adversary. A copy of the DGMO letter designating Mipi-Andrala road as P-A1 is attached as **Appendix "A"** for your perusal please.

4. In these given war like conditions in the year 2021-22 an Engineer Task force (ETF) from the Headquarters 3 Corps was allotted the responsibility of cutting an operational track 3 meter in width. It will be well appreciated that in the given war like situation with enhanced threat to the territorial integrity of the nation and the utmost urgency of redeployment of troops to such vulnerable areas, the Army commenced the work of cutting a track post haste and the mandated clearance from the forest authorities was inadvertently omitted by the Army in view of national interest since these territories were already regarded as disputed area by China and threat of incursion was looming large.

5. As high priority was accorded to this sector by Directorate General of Military Operations the construction of road Mipi-Andrela was handed over to the Border Roads Organisation (62 Road Construction Company/752 Border Roads Task Force /Chief Engineer Project (Udayak)) in the later part of the year 2021 with greater sense of urgency and criticality as time of construction of the road for the redeployment and sustenance of the troops was gaining even more momentum. In the given circumstances of operational urgency, threat to territorial integrity and the looming clouds of war, the Border Roads simply commenced work on the road given its urgency and precedence at the highest level.

It is not out of place to mention that a case for forest clearance for the stretch 6. between Km 0.00 to Km 10.00 of Mipi-Andrela Road was taken with CCF (Cons) & Nodal Officer (FC), Itanagar vide 62 RCC (GREF) letter No.239/FC/M-A/04/E2 dated 30 Apr 2015. A Copy of the letter is enclosed as Appendix "B" for your ready reference please. The Approval in Principle for forest clearance of 29.63 Ha of forest land for construction of Mipi-Andrela road from Km 0.00 to Km 10.00 was accorded by Govt of Arunachal Pradesh vide letter No.FOR.3-198/Cons/2016/1188-1193 dated 13 Sep 2017, but the demanded funds could not be deposited with the forest department since this road was accorded a Priority-II status by the Directorate General of Military Operation during the year 2017-18 due to a change in threat assessment and intentions of our adversary at that point in time. However this fact highlights that our organisation is a law abiding organisation and always endeavors to follow the law of the land. This particular oversight now has been as exception due to the urgency and the sensitive situation that was brewing across Andrala and the urgency for the construction of the road Mipi-Andrala.

7. The Army authorities who had commenced work on the road had not applied for forest & wildlife clearance due to the urgency of construction of the track, which BRO did immediately on the Parivesh Portal as per details FP/AR/Road/148555/202 on 20 Oct 2021 itself. As BRO had applied for the forest clearance and in anticipation of the approval of the same being accorded at anytime and given its importance, we continued to work despite the offence report of 05/11/2022 given the intense circumstances and the threat of loss of national territory unless Mipi was connected to Andrala. The work was only undertaken in view of our national interests, safe guarding of our territorial integrity and the limited working season for its fructification. However continuing the work despite the offence report of 05/11/2022 is regrettable but fully justified considering the overall strategic scenario prevailing during that time and is requested to be condoned as a special case being of national importance.

8. Not withstanding the fact that the above omission was because of the exceptional operation urgency and the sensitive situation along the LAC which necessitated work to be undertaken urgently, our office has issued an advisory on the imperatives of obtaining the Forest and Wildlife clearance before the commencement of any work. A copy of the advisory issued vide letter No. 27560/Forest/Tue/E2 Plg dated 19 Dec 2023 to all subordinate units by the Chief Engineer is attached as **Appendix "C"**.

9. It is also intimated that Stage-I approval has been granted by MoEF&CC, GoI vide letter F.No.3 AN A/182/2023/Ghy/5031-32 dt 04 Jan 2024. An amount of Rs.98,05,06,663/- has also been deposited on 23 Feb 2024 which includes the penalty amount for violation of the Forest Act 1980. The compliance of all conditions of **Stage-I Approval** have also been uploaded on 20 Mar 2024 on Parivesh portal. In view of this, working permission may please be granted as the road is of a strategic importance within 10-20 Km of the LAC.

10. It is also assured that in future, under no circumstance shall any work commence on ground without obtaining the Wildlife & Forest clearance irrespective of the urgency of the work. The assurance shall be honored in letter and spirit.

11. In view of the forgoing it is most humbly requested that this omission which was entirely due to the exigencies of national interest and security and its consequential urgency to ensure territorial integrity, that the notice under 3A and 3B may please be condoned and **Stage-II Approval** may please be granted as this road still retains its strategic importance for defending our territorial integrity.



ADVISORY ON OBTAINING FOREST CLEARANCE (FC) & WILDLIFE CLEARANCE (WLC) FROM THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (MoEF&CC) PRIOR TO COMMENCEMENT OF WORK

1. In a couple of instances, it has come to light that work has commenced on ground without obtaining the mandatory Stage-I & Stage-II FC & WLC from the MoEF&CC.

2. While it is appreciated and understood, that these works have been undertaken only in view of the strategic importance and urgency of execution to connect the border areas for the deployment/redeployment and subsequent maintenance and replenishment of these troops for ensuring the territorial integrity of our country, FC and WLC is yet mandatory. No work should commence under any circumstances without obtaining these compulsory clearances.

3. In addition, the Gazette of India dated 29 Nov 2023, vide Para 12 talks about 'working permission' for the commencement of project work before grant of final approval by the Central Government. The scope of 'working permission' is still unclear and subject to interpretation. A clarification on the same has been sought and till the same is received no work should commence on ground without the receipt of Stage-II permission by the MoEF&CC irrespective of the urgency of work.


