**PROPOSAL FOR DIVERSION OF 65.32 ha. FOREST LAND FOR CONSTRUCTION /IMPROVEMENT OF MIGGING-TUTING ROAD FROM KM 15.000 TO 35.134 BY BRO IN UPPER SIANG DISTRICT OF ARUNACHAL PRADESH**

Sub: Compliance of stage-I of forest proposal.

Sir,

1. The above-mentioned project is for construction of Migging- Tuting road (From Km 15.000 to Km 35.134) in Upper Siang district of Arunachal Pradesh.

2. The project envisaged diversion of **65.32 Ha.** of forest land under Yingkiong Forest Division. Ministry of Environment, Forest & Climate Change, Regional Office- Guwahati, Government of India, vide Government Order No. - F. No. 3-AN A/145/2022/GHY/5203-04; Dated: 09<sup>th</sup> and 13<sup>th</sup> Feb 2024, has accorded the approval in-principle subject to conditions mentioned below whose compliance has been completed on part of user Agency i.e. Border Road organization (BRO) and same has been detailed Para wise below.
