Sub:- Proposal for diversion of 70.214 ha of forest land for construction of 132 KV Transmission Line S/C on D/C tower from Khonsa to Changlang under Comprehensive Scheme for strengthening of transmission and distribution system by Power Department in Tirap & Changlang District of Arunachal Pradesh

Madam,

With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

1	The User Agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ Petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned.	As per revised rate of MoEF&CC's letter dated 22.03.2022, the amount of Net Present Value of the forest land diverted under this proposal for Rs.7,84,22,017/- has been deposited to National Authority (CAMPA) as per e-challan dated 31.01.2023 and deposited on 04.02.2023 at Annexure-I.
2	The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The scheme may include appropriate for anticipated cost increase for works scheduled for subsequent years;	The cost of compensatory afforestation for Rs. 5,01,51,500/- and dwarf species plantation of Rs.36,62,800/- has been deposited to National Authority (CAMPA) as per e-challan dated 31.01.2023 and deposited on 04.02.2023 at Annexure-I .

14	Violation of any of these conditions will amount to violations of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019. 14	The User Agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department. B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Statge-II approval:

1	Legal status of the forest land shall remain unchanged.	Noted
2	The Compensatory Afforestation shall be taken up on double the degraded forest land of 140.43 ha in two patches i.e 116.45 ha in Likabali Reserved Forest in Laipulia Forest Range, Kangku of Likabali Forest Division in Lower Siang District and 23.98 ha in Namdang Reserved Forest under Changlang Social Forestry Division in Changlang District of Arunachal Pradesh within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department at the cost of the user Agency. AS far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided. The CA will be maintained for 10 years.	Noted.

12	The User Agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project. 13	The User Agency shall comply with the guidelines for laying transmission through forest areas issued by Ministry vide letter No. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.	The User Agency has submitted undertaking for this condition at Annexure-XVI.
14	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.	The User Agency has submitted undertaking for this condition at Annexure-XVII.

15	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the User Agency or the project life, whichever is less.	Noted.

17	As per Ministry's letter No. 11-30/96-FC(Pt) dtd. 14.9.2001, if the compliance of stipulated conditions is awaited from the State Govt. for more than 5(five) years, the in-principle approval would be summarily revoked considering that the user agency is no longer interested in the project.	Noted
18	Any other conditions that the Integrated Regional Office, Guwahati, Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forests & Wildlife.	Noted

It is, therefore, requested to kindly issue necessary formal approval for diversion of 70.214 ha forestland for construction of above Transmission line under Section-2 of the Forest (Conservation) Act, 1980 at an early date.
