With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

1	The User Agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ Petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-3/2007-FC dated 05.02.2009. 

No FOR 623/Cons/2015/3173.—WHEREAS, a preliminary notification for constitution of 200.1 ha area of degraded Forest land as Longliang Village Forest Reserve was issued in terms of section 3A of the Arunachal Pradesh Anchal Reserve (Constitution and Maintenance) Act, 1975 (No. 1 of 1976) as amended in 1984 read with section 4 and 5 of the Assam Forest Regulation, 1891 (No. 7 of 1891) vide notification No FOR 623/Cons/2015/1437, dated 6th November, 2017 inviting claims and objections from the interested persons/stakeholders of Longliang villagers

AND WHEREAS, no claims and objections have been received from the stakeholders

AND WHEREAS, in pursuance of the aforesaid notification, the Deputy Commissioner, Khonsa (Settlement Officer), had conducted the public hearing with all the stakeholders in terms of section 5 of the Assam Forest Regulation, 1891 (No. 7 of 1891) on 21st February, 2018.

AND WHEREAS, after detailed deliberations, the Longliang Villagers have agreed and accepted for issuance of the final notification of Longliang Village Reserve Forest for CA Plantation.

NOW, THEREFORE, in exercise of the powers conferred by section 17 of the Assam Forest Regulation, 1891 (7 of 1891) read with section 3A of the Arunachal Pradesh Anchal Forest Reserve (Constitution and Maintenance) Act, 1975 (Act No. 1 of 1976), as amended by the Arunachal Pradesh Anchal and Village Forest Reserve (Constitution and Maintenance) Amendment Act, 1984 (Act No. 4 of 1984), the Governor of Arunachal Pradesh is hereby pleased to notify the final notification to declare that the land described in the Schedule below shall be Village Forest Reserve (VFR) from the date of their publication in the Official Gazette.

Right and Privilege :

1. The right of collection of non-timber forest produce by the Longliang Villagers may be allowed to be collected from the Longliang VFR area for domestic use.
2. The revenue sharing between the Longliang villagers and the State Government shall be as per the provisions of section 5 of the Arunachal Pradesh Anchal Forest Reserve (Constitution and Maintenance) Act, 1975 (No. 1 of 1976).
3. The aforesaid rights and privileges of Longliang Villagers shall be exclusive of payment of CA and any other benefits as had been agreed upon between the parties under any other instrument of agreement.
