With reference to your letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

1	Legal status of the forest land shall remain unchanged.	Noted.
2	The compensatory afforestation shall be taken up by the Forest Department over double the area diverted i.e. 18.30 ha degraded forest land identified at Kassing Puttu Village of Yachui Range, Hapoli Division, Lower Subansiri District at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.	Noted.
3	An original notification declaring Kassing Puttu (Ago) VFR as Village Forest Reserve in accordance of the provisions of the Arunachal Pradesh Anchal and Village Forest Reserve (Constitution and Maintenance) Act, 1975, as amended from time to time and the Assam Forest Regulation, 1891 may be submitted to this Regional Office of MoEF & CC, Shillong, prior to State-II approval. 


