- 1.0 You may kindly be aware that Govt. of India vide letter under Ref.1 above has already accorded In-principle approval for diversion of 0.675 Ha of forest land for construction of 132 kV D/C Roing-Chapakhowa transmission line from Roing to Chapakhowa in Sadiya Station (North Block) Reserved Forest under Doomdooma Forest Division.
- Subsequently, POWERGRID has already deposited all the necessary compensatory 2.0 levies like CA/NPV/Dwarf spp./wildlife mitigation etc. as per the demand received from the concerned Forest Departments. The details of payment made by POWERGRID is stated as below:

- It may be mentioned here that MoEF vide guidelines under Ref.2 & 3 above has already 3.0 clarified that for linear projects like transmission line, In-principle approval under FC Act, may be deemed as "working permission" for tree cutting & commencement of work, if the required funds like CA/NPV/Dwarf species plantation/wildlife mitigation etc. are realised from the User Agency.
- In view of the above and since completion of the aforesaid transmission line is of 4.0 immense importance for reliable power supply to the areas and POWERGRID has already deposited all the compensatory levies to State Forest Department against this forest diversion, we hereby, request your good office to kindly process the proposal fer

Sub: Proposal for diversion of 0.675 ha forest land for construction of 132 KV DC Roing-Chapakwowa Transmission line in Sadiya Station (North Block) Reserved Forest under Doomdooma Division by Powergrid Corporation of India Ltd.

Sir,

This has got reference to the State Government's letter No. FRS 74/2022/60 dated 07.06.2022 and FG. 27/FCA/Proposal/Power Grid/Doomdooma Divn. dated 30.11.2022 on the subject seeking prior approval for the Central Government under Section 2 of the FCA, 1980.

After careful examination of the proposal and State Govt letter FG. 27/FCA/Proposal/Power Grid/Doomdooma Divn. dated 30.11.2022 "In Principle Approval/Stage- I" clearance of the Central Government is hereby granted for diversion of 0.675 ha forest land for construction of 132 KV DC Roing-Chapakwowa Transmission line in Sadiya Station (North Block) Reserved Forest under Doomdooma Division by Powergrid Corporation of India Ltd. subject to the following conditions:

- A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.
- The user agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal in the revised rates, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No 5-3/2007-FC dated 05.02.2009 and File No.5-3/2011-FC(Vol-I) dated 21.03.2022. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned;
- 2) The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The scheme may

include appropriate for anticipated cost increase for works scheduled for subsequent years;

- 3) All the funds received from the user agency (CA and dwarf plantation cost, NPV, etc) under the project shall be transferred/ deposited to Compensatory Afforestation Fund of Arunachal Pradesh State managed by the Ad-hoc CAMPA only through eportal (<u>https://parivesh.nic.in/</u>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance;
- 4) The user agency shall deposit 2% of the total project cost into the account of CAMPA which will be utilized to prepare and implement wildlife mitigation plan to mitigate the Human Elephant Conflict and precautionary measures to ensure free movement of the elephants in the landscape.
- 5) The State Govt shall ensure that under no circumstances, implementation of such mitigating measures envisaged in Human Elephant/wildlife Conflict mitigation and wildlife conservation plan should be delayed beyond a period of 2 years to ensure commencement of rejuvenation of ecosystem services lost from the forest area allowed for non-forestry use of forest land at the earliest possible time.
- 6) The State Govt shall submit Human Elephant/wildlife Conflict mitigation and wildlife conservation plan approved by Chief Wildlife Warden, Govt of Assam along with detail cost of its implementation.
- 7) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/);
- 8) The KML files of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage II approval, as the case may be;
- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
- 8) The user agency shall explore the possibility of successful translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department;
- 9) The charges for felling, logging and transportation of project affected trees should be collected from the user agency at the rates approved by the State Govt and deposited with the DFO concerned for utilization immediately following the diversion of forest land.
- 10) The expenditure like boundary walls, stone pillars, demarcation charges, cost of damage of trees the funds on these accounts should, be deposited with the DFO concerned.
- 11) The User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.

- 12) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
 13) Violation
- 13) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-Fc dated 28.03.2019.
- 14) Monitoring of the proposed area shall be conducted by IRO, Guwahati prior to Stage-II approval.
- B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:
- (1) Legal status of the forest land shall remain unchanged.
- (2) The compensatory afforestation shall be taken up on double the degraded area i.e. 1.4 ha at Sadiya Station (North Block) Reserved Forest in Doomdoma Forest Division of Tinsukia District within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided. The CA will be maintained for 10 years.
- (3) At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
- (4) The User Agency shall obtain the Environment Clearance as per the provisions of Environment (Protection) Act, 1986, if required;
- (5) No labour camp shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- (6) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- (7) No damage to the flora and fauna of the adjoining area shall be caused;
- (8) The layout of the proposal shall not be changed without the prior approval of the Central Government.
- (9) The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
- (10) The User Agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- (11) The user agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

- (12) The User Agency shall comply with the guidelines for laying transmission through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 &19/11/2014.
- (13) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (14) The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- (15) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (16) As per Ministry's letter No 11-30/96-FC(Pt) dt 14.9.2001, if the compliance of stipulated conditions is awaited from the State Govt for more than 5(five) years, the inprinciple approval would be summarily revoked considering that the user agency is no longer interested in the project.
- (17) Any other conditions that the Integrated Regional Office, Guwahati, Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

Sub: Guidelines for diversion of forest land for non-forest purpose under the Forest (Conservation) Act, 1980- Simplified procedure for grant of permission for felling of trees standing on forest land to be diverted for execution of linear projects: *reg*.

Sir,

I am directed to say that guidelines issued under the Forest (Conservation) Act, 1980 provides that forestry clearance will be given in two stages. In 1st stage, the proposal shall be agreed to in principle in which usually the conditions relating to transfer and mutation of equivalent non-forest land for compensatory afforestation and realization of funds for raising compensatory afforestation thereof and NPV etc. are stipulated and after receipt of compliance report from the State Government in respect of the stipulated conditions, formal approval under the afore-mentioned Act is issued. Central Government while according inprinciple approval stipulates a condition that till receipt of the formal/ final approval of the Central Government, transfer of forest land to the User Agency shall not be affected by the State Government.

This Ministry has received representation to relax the above conditions in respect of projects involving linear diversion of forest land and allow the user agency to fell trees standing on the forest land even before grant of formal/final approval by the Central Government once the conditions relating to transfer and mutation of equivalent non-forest land for compensatory afforestation, wherever required and funds for NPV and raising compensatory afforestation etc. are complied with.

The matter has been examined in this Ministry and after careful consideration with a view to facilitate speedy execution of projects involving linear diversion of forest land such as laying of new roads, widening of existing highways, transmission lines, water supply lines, optic fiber cabling, railway lines *etc.*, the Central Government hereby decides that for linear projects of National Highways Authority of India (NHAI), Border Roads Organization (BRO), Central Public Works Department (CPWD), Ministry of Road Transport and Highways (MoRTH), Ministry of Railways, and various other central agencies, in-principle approval under the Forest (Conservation) Act, 1980 may be deemed as the working permission for tree cutting and commencement of work, if the required funds for compensatory afforestation, NPV, wildlife conservation plan, plantation of dwarf species of medicinal plants, and all such other compensatory levies specified in the in-principle approval under the Forest (Conservation) Act, 1980 may be deemed as the working permission for tree cutting and compensatory levies specified in the in-principle approval are realised from the user agency. In case of linear projects of other user agencies, in-principle approval under the Forest (Conservation) Act, 1980 may be deemed as the working permission for tree cutting and commencement of work, if the required funds for compensatory levies as above, stipulated in the in-principle approval are realised from the user agency. Sir,

I am directed to refer to guidelines on the afore-mentioned subject issued by this Ministry vide letters of even number dated 8th August 2014 and 15th January 2015 on the above-mentioned subject wherein this Ministry communicated a simplified procedure for grant of permission for tree cutting and commencement of work of linear project in forest land, and to say that the said guidelines were examined by the Hon'ble National Green Tribunal (NGT) in the Original Application No. 52 of 2015 in the matter of Milind Pariwakam & Anr. versus Union of India.

2. The Hon'ble NGT in their order dated 13th March 2015 disposed of the said O.A. by issuing certain directions.

3. In compliance of directions issued by the Hon'ble NGT in the said O.A. and in supersession of this Ministry's said letters/guidelines of even number dated 8th August 2014 and 15th January 2015, I am directed to say as below:

- (i) With a view to facilitate speedy execution of projects involving linear diversion of forest land such as laying of new roads, widening of existing highways, transmission lines, water supply lines, optic fiber cabling, railway lines *etc.*, in-principle approval under the Forest (Conservation) Act, 1980 (FC Act) issued by the Central Government may be deemed as the working permission for tree cutting and commencement of work, if the required funds for compensatory afforestation, net present value (NPV), wildlife conservation plan, plantation of dwarf species of medicinal plants, and all such other compensatory levies specified in the in-principle approval are realised from the user agency and where necessary, for compensatory afforestation, transfer and mutation of non-forest/revenue forest land in favour of State Forest Department is affected;
- (ii) After the afore-mentioned compensatory levies specified in the in-principle approval are realised from the user agency and where necessary, for compensatory afforestation, transfer and mutation of non-forest/revenue forest land in favour of State Forest Department is affected, the State Government or a Senior Officer not below the Rank of a Divisional Forest Officer, having jurisdiction over the forest land

In inviting a reference to the subject and letters quoted above, I am to state that the Government of Assam is pleased to accord Working Permission to the User Agency i.e. Power Grid Corporation of India Ltd. to commence the work and cutting trees in forest area for the proposed diversion of 19.791 ha of forest land for shifting of 132 KV S/C Gohpur - Nirjuli Transmission line for Loc No. 42 to Loc No.64 due to the upcoming Greenfield Airport at Hollongi in Gohpur Reserved Forest under Sonitpur East Division, Biswanath Chariali for a period of one (1) year. subject to the following conditions :

1) Before felling of trees and commencement of works, an agreement shall have to be executed by the User Agency i.e. Power Grid Corporation of India Ltd. with the Divisional Forest Officer. Sonitpur East Division, Biswanath Chariali that they shall abide by all the conditions stipulated in the 'In-Principle Approval' granted by the Govt. of India vide letter Reference No.3-AS C 074/2021-GHY/1751-1752 Dated 28/12/2021. All the conditions laid down in the 'In-Principal Approval' shall be incorporated in the Agreement and any violation of the conditions or the Forest (Conservation) Act, 1980 or the Rules made thereunder during the working permission shall lead to cancellation of the working permission without prejudice to any other legal action as per law/Rules.

However on grant of Final Approval by Govt. of India, a separate/ additional agreement shall have to be executed by the Divisional Forest Officer, Sonitpur East Division, Biswanath Chariali with the user agency as was being done earlier.

- The Divisional Forest Officer, Sonitpur East Division, Biswanath Chariali shall take requisite measures to carry out felling of trees departmentally, as expeditiously as possible, standing on the forest land for which the 'In Principle Approval' has been granted by the Central Government as per the prescribed procedure.
- The Divisional Forest Officer, Sonitpur East Division, Biswanath Chariali shall monitor the 3) marking and feeling of trees which should be restricted to the bare minimum for the project.
- 4) Felling of trees and commencement of work shall be carried out only after accurate demarcation of area and fixing of 4 feet high RCC boundary pillars (with GPS coordinates and forward/backward bearing) along the boundary of the forest area proposed for diversion.

You are requested to take necessary action accordingly.




