In the above cited subject POWERGRID has applied under Forest Conservation act 1980, for the construction of LILO of 400 KV Bamnauli-Jhatikara Transmission Line at 400/220KV GIS Dwarka S/S with the diversion of 10.9736 Hectors of forest land vide online portal Parivesh ID no: - FP/DL/TRANS/39469/2019 dated 23.03.2019. The proposal has been granted stage-1 approval by Regional office Jaipur MOEF & CC vide their letter Ref. No. 8B/Delhi/04/02/2020/40 dated 07.12.2020 with some terms and conditions. The point wise compliance of these terms and conditions are as under-

3. Compensatory afforestation shall be taken up by the Forest department over 10.9736 non-forest land the mentioned places in stage-1 approval letter at the cost of user agency. As far as possible a mixture of local indigenous species planted shall be and monoculture of any species may be avoided.

The CA land area is mentioned below: -

- 1. Area measuring 6.13 ha. at Chiragaha Janubi & Indraprastha, Tehsil/ forest range- Anand Vihar range District- East Delhi at block No./Compartment no- 57 and 702.
- 2. Area measuring 4.85 ha. at village-chragaha sumali at Forest range/Tehsil sahadara District- east Delhi at block/Compartment no- 16.
- 4. The Non-Forest land shall be transferred and mutated in favor of the state forest department.

The required non-Forest land area measuring 6.13 ha. & 4.85 ha. (Total 10.98 ha.) as mentioned in stage-1 approval letter has been handed over to forest department. Necessary documents regarding handing over is enclosed at annexure-3.

As per the recommendation of FAC, the area proposed for CA on DDA land against diversion of any forest land in Delhi under FCA-1980 act, needs not to be mutated in favour of Forest department. (Recommendation of FAC File no. 8-10/2015-FC, dated 31.07.2019.)

5. The cost of CA at the prevailing wage rate as per compensatory afforestation scheme and the cost of the survey, demarcation and erection of permanent pillars, if required on CA land shall be deposited in advance with the forest department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for work schedule for subsequent years.

Vide F.17/WFD/COT/18-Letter No.-19/11575-78 dated -20.01.2021Department of Forest and Wild Life, Delhi raised a demand of Rs.8,93,59,746.00 (Rupees Eight Crore Ninety-three Lakh Fifty-Nine Thousand Seven Hundred Forty-Six Only) against CA Scheme. Same has been deposited to Forest Department by POWERGRID Vide Transaction ICIC512000000694 on dated 01.05.2021. (Payment receipt copy enclosed).

6.The state Govt. shall charge the Net Present Value (NPV) for the 10.9736 ha. forest area to be diverted under this proposal from the user agency as per the orders of the Hon'ble supreme court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. WPC No. 202/1995 and as per the guidelines issued by the ministry vide letters No- 5-1/1998-FC (pt.II) dated 18/09/2003 as well as per the letters No-5-2/2206-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.

Vide F.17/WFD/COT/18-Letter dated. 19/11571-74 dated -20.01.2021 Department of Forest and Wild Life, Delhi raised a demand of Rs.97,33,583 (Rupees Ninety-Seven Lakh thirty-three thousand Five hundred Eighty-Three Only) against NPV and same has been deposited to Forest Department by POWERGRID Vide Transaction No.-. ICIC512000000694 on dated 01.05.2021. (Payment receipt copy enclosed).

7. Additional amount of the NPV of the diverted forest land, if any becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the expert committee shall be charged by the state Govt. from the user agency. The user agency shall furnish an undertaking to this effect.

An undertaking for payment of additional NPV has been submitted at annexure-4.

8. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the state Forest department and the cost of felling of trees shall be deposited by the User agency with the State Forest Department.

An undertaking for restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the state Forest department is enclosed at annexure-5. The cost of felling of trees shall be bear by PowerGrid

9. The user agency in consultation with the state forest department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line and deposit the cost of execution of the said scheme to the State Forest department.





May kindly see the summery of expenditure for plantation of 10974 Nos. saplings on non-forest land against diversion of land under FCA, 1980, for construction of LILO of 400 Kv Bamnauli-Jhatikara T/L at Dwarka Sec-05, Delhi:

- 1. The Total cost estimate for plantation of 10974 saplings over an area of 10.9736 ha. land located near Shastri Park Metro Station and adjoining to Yudhister Setu on Easter Bank of River Yamuna & at NH 24 on Eastern Park of River Yamuna, (land allocated by Delhi Development authority for carrying out Compensatory afforestation) as per existing norms of Compensatory plantation in department of Forest and wildlife, GNCTD under DPTA, 1994, is Rs 5700/ (five thousand Seven Hundred only) per sapling for establishment and maintenance up to 07 years.
- 2. As per the existing ratio, 1000 sapling can be planted in 01 ha. Therefore, 10974 saplings are to be planted in 10.9736 ha. land.
- 3. The Estimate therefore is 8142.86 X 10974 = Rs. 8,93,59,746.00 (Rs Eight Crore Ninety-Three Lakh Fifty-Nine Thousand Seven hundred forty-six only) for establishment and maintenance of plantation of 10974 saplings for 10 years. (For per sapling cost/ expenditure for 10 years is (5700/7 X10) =8142.86 Rs.)







- 1. Legal status of the forest land shall remain unchanged.
- 2. Forest land will be handed over only after required non-forest land for the project is handed over to the user agency.

3. Compensatory afforestation shall be taken up by the Forest Department over 10.9736 ha. Non Forest land (as detailed below) at the cost of the user agency.

As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

- 4. The non-forest land which has to be transferred and mutated in favour of the State Forest Department.
- 5. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

- 6. The State Government shall charge the Net Present Value (NPV) for the 10.9736 ha, forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.
- 7. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 8. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 9. The User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line and deposit the cost for execution of the said scheme to the State Forest Department.
- 10. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 11. The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- 12. The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.
- 13. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 14. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 15. No labour camp shall be established on the forest land.
- 16: Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 17. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 18. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 19. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 20. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 21. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 22. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 23. DFO should certify that no work have been carried out in violation of Forest (Conservation) Act, 1980.
- 24. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal.
