In compliance of the Ministry of Environment and Forest (MoEF), Government of India's Letter No. 11-9/98-FC (pt) Dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for Short) on the Forest Land proposed to be diverted for non – forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 17.82 Hectares for forest land proposed to be diverted in favour of Executive Engineer, PWD, Division No.II (Road), DNH, Silvassa (name of User agency) for Diversion of Protected Forest land for Widening for Existing road stretch from Khanvel Chowk to Dudhani Junction.

It is further Certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 17.82 Hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and District Level Committee are enclosed as annexture NOT APPLICABLE (As per MoEF Letter dated 5th February 2013).
- (b) The diversion of Forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it; NOT APPLICABLE (As per MoEF Letter dated 5th February 2013).

(c) The proposal does not involve recognized rights of primitive Trible Groups and preagricultural communities.
