

This refers to letter No. FCA-1021/1-05/21/S.F-186/F dated 24.11.2021 of the State Govt. of Gujarat on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under Section 2 of Forest (Conservation) Act, 1980.

- 3. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 4. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 5. The proposed optical fiber cable is passing through Shoolpaneshwar Wildlife Sanctuary. In this regard required Wildlife Clearance from Standing Committee of Wildlife shall be obtained.
- 6. The working permission for the project shall be issued only after receiving of approval from Standing Committee of National Board of Wildlife (NBWL).
- 7. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of concerned Divisional Forest Officer.

- 16. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- 17. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.

After receipt of compliance report on fulfillment of all of the above conditions from the State Government, proposal will be considered for Final/Stage-II approval under Section-2 of the Forest (Conservation) Act, 1980. The User Agency shall take up the work as per the guidelines in force and after ensuring that all necessary clearances for the entire stretch are in place. Working permission, if any issued, shall be intimated to IRO, Gandhinagar. Transfer of forest land shall not be effected till Final/Stage-II approval is granted by the Central Government in this regard.

Further, it may also be noted that this **In-principle** / **Stage-I** approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this In-principle approval shall be revoked after **five** (05) years.

- 2. The proposal was placed before the State Board for Wildlife (SBWL) in its 20th meeting held on 22-12-2021 for consultations, The SBWL has approved and recommended the proposal in its meeting vide reference no. 2 above with certain conditions.
- 3. The proposal was sent to Forest and Environment Department, Government of Gujarat vide reference no. 3 above for onward submission to MoEF&CC, GoI. The said proposal was submitted to MoEF&CC, GoI for consideration of Standing Committee of National Board for Wildlife (NBWL) vide reference no. 4 above. The proposal was discussed in 70th meeting of the Standing Committee of NBWL held on 13-10-2022 and the Standing Committee of NBWL recommended the proposal vide reference no. 5 above in its meeting with certain conditions.

Hon ble Supreme Court of India has passed an order dated 05-10-2015 in reference to different LAs in Writ Petition (Civil) 202/95 vide reference no. 6 above. The order of the Hon ble Supreme Court of India is reproduced as under:

"All matters for grant of permissions for implementation of projects in areas falling in National parks/sanctuaries, including rationalization of boundaries etc. will be committeed by the Standing Committee of the National Board for Wildlife ("NBWL") on its own merits and in conformity with the orders and directions passed by this Court from time to time, i.e. on 14.02.2000, 13.11.2000, 9.5.2002, 16.12.2002... 25.11.2005 and 14.09.2007 other subsequent clarificatory and orders Judgment(s) passed by this Court including the Goa Foundation Judgment, i.e. Goa Foundation Vs. Union of India & Ors., reported in (2014) 6 SCC 590.

We request the NBWL to furnish a copy of the orders passed by it within 30 days' time to the C.E.C. The C.E.C. is at liberty, if, for any reason, they are aggrieved by the decision of the Standing Committee of NBWL to approach this Court by filing an appropriate petition/application.

In all those matters where there is already decision of the Standing Committee of the NBWL shall abide the parties with all the conditions imposed therein.


If any party is aggrieved by the decision of the Standing Committee of the NBWL, they are at liberty to approach an appropriate forum for appropriate relief(s).

With the aforesaid observations and directions, we dispose of the Interlocutory Applications/matters specified in Annexure-II to the note supplied by Shri Harish Salve, learned amicus curiae."

Therefore in view of the references mentioned and explained above, the permission is hereby granted to the Reliance Jio Infocom Limited, Ahmedabad for Proposal for use of 0.701 ha. land of Shoolaneshwar Sanctuary for setting up of 4G Telecommunication Towers in 7 villages of Narmada District & laying of Optical Fiber Cable in Narmada District, Gujarat. subject to following conditions:

Conditions:

- The User Agency shall not violate any regulatory provisions under Section 9, 17 A, 27, 29, 30, 31 & 32 of Wildlife (Protection) Act, 1972.
- The User agency shall not destroy wildlife habitat including fauna and flora of the Sanctuary.
- The User Agency shall not use the area for the proposed work other than the area permitted.
- The User Agency shall not establish any temporary or permanent labor camp in the Sanctuary.
- The User Agency or his contractor shall not create any fire places inside the Sanctuary.
- The user agency will have to prepare a conservation plan relevant to the biological entity affected due to the project and deposit the fund before initiating any work on the land.
- All the material required for the work shall be prepared outside the sanctuary.
- The work in the Sanctuary will be allowed only in the day time from 8 AM. to 6 PM.



- 9. Approval under Forest Conversation Act, 1980, if required, shall be obtained separately for use of forest land.
- 10. The User Agency shall deposit NPV for the use of land of Protected Area as per the existing rates before initiating any work on the allotted land.
- The User Agency shall restore the land in its original form after completion of the work.
- An annual compliance certificate on the stipulated conditions shall be submitted by the project proponent to the State Chief Wild Life Warden and an annual compliance certificate shall be submitted by the State Chief Wildlife Warden to Government of India.


