This office has given an "In Principle" approval for Proposal for Grant of Permission of laying Optical Fibre Cable with Protection pipes along the roads from Navsari T.E to Bilimora T.E via Gandevi.(30300 Mtr or 1.3635 Hectare) vide letter dated 12.10.2022. referred above at (3).

- 1. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 4. The User Agency will have to make good the forest land after use/maintenance work. No tree shall be cut.

- 5. The User Agency will be liable to make good any loss to Forests/Environment caused to the the use of the said land by the user agency.
- 6. The User Agency will seek permission from the Roads & Buildings Department /Science and Technology Department, Sachivalaya, Gandhinagar.
- 7. The optical fiber cable will be laid underground in a trench of not more than 2.00 meter depth and 1.00 meter width in between rows of road side plantation.
- 8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
