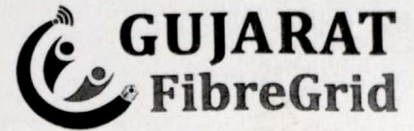

3	The user agency shall generate challan through OSMEFWC portal before making payment for stage-II clearance process. All the fund shall be deposited through OSMEFWC portal by the user agency.	NA
4	In future if any amount regarding net present value for compensatory a forestation is required, the user agency is bounded to pay in favour of Deputy Conservator of Forest.	Agreed
5	The forest land shall not be used for any purpose other than that specified in the FCA proposal.	Agreed
6	The user agency will have to obtain permission from the under signed for carrying out any maintenance works in future.	Agreed
7	The user agency will have to make good the forest land after use/maintenance works. No trees shall be cut.	Agreed
8	The user agency will be liable to make good any loss to forest/environment cause due to use of the said land by the user agency.	Agreed
9	The user agency will seek permission from Road & Building Department/Science and Technology Department, Sachivalay, Gandhinagar, if required so	Agreed
10	The line will be laid underground in a trench of the depth 1.65 Mtr & width 30-45 cm in between rows of road side plantation.	Agreed
11	The user agency shall submit the detail regarding compliance of MoEF's guideline dated 03/08/2009 & 05/02/2013 with regard to the schedule tribes & other forest dwellers (Recognition of Forest Rights) Act-2006	Attached
12	The additional condition under chapter 5 of Forest Conservation Act. 1980 shall be applicable to this proposal as the Government of Gujarat's Resolutions No. FCA-1013/11-10/11/SF-24/F, dated 12/06/2015. The user agency shall comply additional condition as per aforementioned resolutions.	Agreed
13	Any other condition which the Nodal officer (FCA)/the State Government may stipulate from time to time.	Agreed
