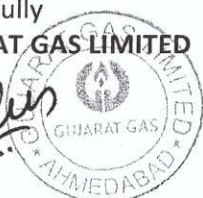

Please find enclosed herewith a proposal along with Annexures in four Copies for granting of No Objection Certificate for laying of 125mm/90mm/63mm/32mmØ MDPE Gas Pipeline in Protected Forest land as mentioned above.

It may kindly be noted that pipeline will be laid in Along/Across SH-2 (Jhalod-Suksar State Highway) (Ahmedabad-Santrampur) in Jhalod town and surrounding areas (CA-02) to supply Natural Gas in Taluka Jhalod of Dist. Dahod as said herein.

The pipeline will be laid by excavation of a narrow strip trench of 60 cm width and by horizontal directional drilling (HDD) for pushing the casing pipe wherever required. The same strip of the trench will be reinstated to its original condition and the land area in question will not be required to be handed over to the Gujarat Gas Limited for its exclusive use. The Applicant will not have any right other than that of the user. It is also intimated that no structure will be erected on the pipeline route.

The pipeline route proposed is most economical and it is badly necessary to lay Along/Across SH-2 (Jhalod-Suksar State Highway) (Ahmedabad-Santrampur) in Jhalod town and surrounding areas (CA-02) to supply Natural Gas in Taluka Jhalod of Dist. Dahod in as stated herein above. It is not possible now any other alternative route except to use the proposed route of pipeline. R&B Division, Dahod has been requested to allow laying pipeline as stated herein above and permission is likely to be received shortly.

It is not possible to get land for laying the pipeline other than the road being used by the Forest Department.



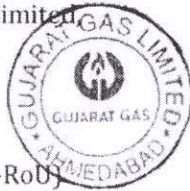



The Government of India, Ministry of Environment, Forest & Climate Change has delegated the power for general approval to the State Governments of various categories like optical fiber cables, underground laying of telephone lines and underground laying of drinking water supply pipelines from time to time under section-2 of the Forest (Conservation) Act, 1980 for diversion of forest land.


The GoI, MoEF&CC has extended the said general approval to underground laying of CNG/ PNG pipelines along the roads within existing right of way not falling in National Parks and Wildlife Sanctuaries, without felling of trees, where the maximum size of the trench is not more than 2.00 meter depth and 1.00 meter width subject to fulfilment of conditions stipulated in the Handbook of Forest Conservation Act, 1980 & Forest Conservation Rules, 2003 (Guidelines & Clarifications) Year 2019 in Chapter-4(4.2).

3. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e.portal.
4. User Agencies shall generate challan through OSMFWC portal before making payment for Stage-II Clearance process. All the fund shall be deposited through OSMFWC portal by the User Agency.

5. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
6. User agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
7. User agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.
8. User agency will be liable to compensate any loss to Forests/Environment caused due to the use of the said land by the user agency.
9. Project area is not a part of Protected area/Sanctuary/National Park and the project area is 80.00 Km. away from the Ratanmahal Wildlife Sanctuary.
10. User agency will seek permission from the Road & Building Department/Science & Technology Dept. Sachivalaya, Gandhinagar, if required so.
11. Gas pipe line will be laid underground in the trench of maximum depth of 2.00 meters and width of 0.40 meters, in between rows of road side plantation.
12. User Agency shall submit the details regarding compliance of MoEF's guideline dated 03.08.2009 and 05.02.2013 with regard to the Scheduled Tribe & Other Forest Dwellers (Recognition of Forest Rights) Act, 2006. FRA shall be uploaded on e.portal (<https://parivesh.nic.in/>) before Formal Approval.
13. Additional Conditions as per the Government of Gujarat's Resolution no. FCA-1013/11-10/11/SF-24/F, Dt.12.06.2015 shall be complied with.
14. Any other condition, which the State Government or Nodal Officer (FCA) may stipulate from time to time.
15. The Compliance report shall be uploaded on e.portal (<https://parivesh.nic.in/>).

After receipt of the compliance report on the fulfilment of condition no. (2), (3), (4), (5), (12), (13) & (15) mentioned above from you, order of formal approval will be issued by this Department.
