Please find enclosed herewith a proposal along with Annexures in Four Copies for granting of No Objection Certificate for laying of 125mm Ø MDPE Gas Pipeline in Protected Forest land as mentioned above.

It may kindly be noted that pipeline will be laid in Along SH-119(Asphalt Road) (Than-Tarnetar) Roads as said herein.

The pipeline will be laid by excavation of a narrow strip trench of 60 cm width and by horizontal directional drilling (HDD) for pushing the casing pipe wherever required. The same strip of the trench will be reinstated to its original condition and the land area in question will not be required to be handed over to the Gujarat Gas Limited for its exclusive use. The Applicant will not have any right other than that of the user. It is also intimated that no structure will be erected on the pipeline route.

The pipeline route proposed is most economical and it is badly necessary to lay Along SH-119(Asphalt Road) (Than-Tarnetar) as stated herein above. It is not possible now any other alternative route except to use the proposed route of pipeline. R&B Division, Surendranagar office has been requested to allow laying pipeline as stated herein above and permission is likely to be received shortly.



The Government of India, Ministry of Environment, Forest & Climate Change has delegated the power for general approval to the State Governments of various categories like optical fiber cables, underground laying of telephone lines and underground laying of drinking water supply pipelines from time to time under section-2 of the Forest (Conservation) Act, 1980 for diversion of forest land.

The GoI, MoEF&CC has extended the said general approval to underground laying of CNG/ PNG pipelines along the roads within existing right of way not falling in National Parks and Wildlife Sanctuaries, without felling of trees, where the maximum size of the trench is not more than 2.00 meter depth and 1.00 meter width subject to fulfilment of conditions stipulated in the Handbook of Forest Conservation Act, 1980 & Forest Conservation Rules, 2003 (Guidelines & Clarifications) Year 2019 in Chapater-4(4.2).
