With reference to above said subject matter In-principle approval has been issued vide above letter ref. 1 against diversion of 9.607 Ha. of Protected Forest. Demand note towards NPV (Net Present Value) & Processing Fees, Registration Fees, Compensatory afforestation also issued from your office vide ref. 2 above.



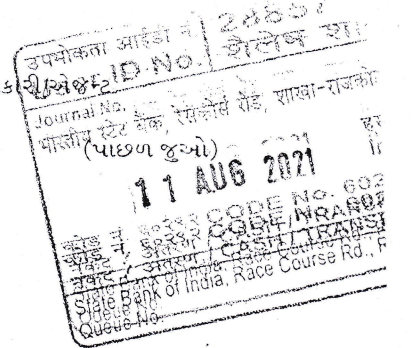
