With reference to above said matter, In-Principle approval has been granted vide letter reference (1) above for diversion of 5.5125 Ha. Of Protected Forest Land for Widening & Strengthening of Sutrapada Fatak- Sutrapada Dhamlej road MDR between km. 10/500 to 21/000 in Veraval & Sutrapada Taluka of Gir-Somnath. Demand Note towards Net Present Value (NPV) & CA Scheme has been received from your good office vide letter reference (2) above. With reference to the above subject and as per the instructions through letter under reference, this office is hereby submitting the status cum compliance of necessary conditions for your kind consideration.
