We appreciate for grant of Stage-1 in principle permission via letter no. 6-GJC 004/2020-BHO/134-7, Dt.17/04/2020 for laying of Diversion of 6.75 ha Protected Forest land for the work of widening and strengthening of Nadiad-Petlad Road Km. 0/00 to 9/00 (Chainage 3/00 to 9/00, SH No.89) in favour of Executive Engineer, R & B Division in Nadiad District of Gujarat. Further in order to obtain Stage-2 permission for the same proposal we here by submit compliance report as per conditions stipulated in stage-1 permission letter.

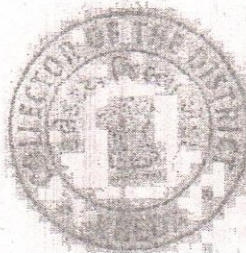
