With reference to above said matter, In – Principle approval has been issued vide letter above against diversion of 16.37325 ha. in following term & conditions. And Point wise compliance against term & Condition are as below.

1.	Legal status of the forest land shall remain unchanged.	The user agency agrees with this condition.
2.	Forest land will be handed over to the user agency only after required non – forest land for the project is handed over by the User Agency.	Non-forest land is not required for this proposal.
3.	Compensatory afforestation :	
a)	Compensatory afforestation shall be taken up by the Forest Department over 33.00 ha degraded – forest land (Survey No. 162,159 Pt, Village – Lambho. Taluka - Khanpur, Dist. Mahisagar). As far as possible, a mixture of local indigenous species shall be avoided.	
b)	Total no. of saplings to be planted shall not be less than nos. 36,663 (33.00 ha. X 1111) in CA land. The composition of saplings (number species wise) to be planted shall be as per the National Forest Policy and shall be recorded in plantation journal.	

c)	The standard size sapling (minimum height & minimum collar girth species wise) as approved by the State govt. shall be planted in the selected CA land.	
d)	The height and collar girth (specie wise) shall be measured & recorded at the time of plantation and in November of plantation year. Further, data of height, collar girth and survival percentage (Species wise) twice a year (April & November month) shall be recorded & records shall be maintained.	
e)	The sturdiness Quotient of the plants at the plants at the time of plantation shall not be more than 7.	
f)	All the live stumps & pollards upto 90 cm Girth shall be dressed from ground level for the purpose of regeneration & record shall be kept in plantation journal.	
g)	Plantation shall be taken up before end of 2021 monsoon.	
4.	The Cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land shall be deposited in advance with the forest Department by the project authority. the CA will be maintained for 10 years. the scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years. b)	The latest ISFR of FSI shall be followed for determination of density for the purpose of NPV rates as per para 3.8 of FCA 1 handbook 2019.	
c)	Additional amount of the NPV of the diverted forest land. If any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The user agency agrees with the additional amount of NPV of the diverted forest land as per direction of the hon'ble supreme court.
7.	User Agency shall restrict the felling of trees up to 631 nos. in the diverted forest land and trees shall be felled under the strict supervision of the State /forest Department. 
