This refers to letter No. FCA-1021/7-16/21/S.F-210/F dated 16.12.2021 of the State Sir, Govt. of Gujarat on the above mentioned subject seeking prior approval of the Ministry of E wironment, Forest & Climate Change under section 2 of Forest (Conservation) Act, 1980.

The proposal was duly considered and approved by the Regional Empowered Committee in its meeting held on 21.01.2022 for issuance of In-Principle/Stag -I approval. Therefore, the undersigned, on the behalf of the Central Government, conveys In-Principle/Stage-I Approval for diversion of 10.80 ha Protected Forest for cc astruction of p ıgdandi on Ahmedabad-Viramgam-Mandal-Dasada- Panchasar-Shankheshwar Road in P stan District in favour of Executive Engineer, R & B Division, Patan of Guja at subject to tl e following general, standard and specific conditions: -

A: Conditions which needs to be complied prior to handing over of forest land by the

State Forest Department:

1. The cost of compensatory afforestation at the prevailing wage ates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in adv once with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost incre se for works scheduled for subsequent years.

2. The State Government shall charge the Net Present Value (NPV) for he 10.80 ha forest area to be diverted under this proposal from the User Agency as | er the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003 28/03/2003, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2 007-FC dated 05/02/2009 and 5-3/2011-FC(Vol-1) dated 06.01.2022 in this regard.

3. Additional amount of the NPV of the diverted forest land, if any, becor ing due after finalization of the same by the Hon'ble Supreme Court of India on receip : of the report

from the Expert Committee, shall be charged by the State Government from the Jser Agency. The User Agency shall furnish an undertaking to this effect.

4. Plantation of shade and fruit bearing trees shall be carried out compulsoril ton

one side and wherever possible on both sides of the pagdandi.

5. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed

certificate from the concerned District Collector.

6. The KML file of the area to be diverted and the CA areas shall be uploaded on the extreme watch portal with all requisite details, before issuing working permission towards linear projects or submitting compliance report for seeking Final/Stage-II approval, as the case may be.

7. All the funds received from the user agency under the project shall be trans erred/

deposited to CAMPA fund only through e-portal.

B: Conditions which needs to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Final/Stage-II approval:

1. Legal status of the forest land shall remain unchanged.

- 2. Compensatory afforestation shall be taken up by the Forest Department over 2 ..00 has of de-graded forest land, Compartment No. 104, Village- Rajusara, Taluka- Sa stalpur District- Patan, Gujarat at the cost of the user agency. As far as possible, a mit ture of local indigenous species shall be planted and mono-culture of any species nay be avoided.
- 3 User agency shall restrict the felling of trees to 133 trees/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.

4. No damage to the flora and fauna of the adjoining area shall be caused.

G. The layout plan of the proposal shall not be changed without prior approval c 'Central Government.

6. No labour camp shall be established on the forest land.

7. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

8. The boundary of the diverted forest land shall be suitably demarcated on gro ind at the project cost, as per the directions of the concerned Divisional Forest Officer.

9. No additional or new path will be constructed inside the forest area for trar sportation of construction materials for execution of the project work.

10. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whicheve is less.

11. The forest land shall not be used for any purpose other than that speci ied in the project proposal.

12. The forest land proposed to be diverted shall under no circumstances be tr. nsferred to any other agencies, department or person without prior approval of Govt. o India.

any other agencies, department of person management and integrated Regional Office, above stated conditions to the State Government and Integrated Regional Office, Gandhinagar by the end of March every year.

14. The User Agency shall comply with all the provisions of the all ...cts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

15. Violation of any of these conditions will amount to violation of Forest (Conservation)

Act, 1980 and action would be taken as per the MoEF&CC Guideling F. No. 11-

16. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protect in and development of forests & wildlife.

17. The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).

After receipt of compliance report on fulfillment of all of the above conditions f om the State Covernment, proposal will be considered for Final/Stage-II approval under Sect on-2 of the Fo est (Conservation) Act, 1980. The User Agency shall take up the work as per the guidelines in force and after ensuring that all necessary clearances for the entire stretch are in place. Working permission, if any issued, shall be intimated to IRO, Gandhinagar. Transfer of forest land shall not be effected till Final/Stage-II approval is granted by the Central Government in this regard.

Firther, it may also be noted that this In-principle / Stage-I approval shall be val d for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this In-principle approval shall be revoked after five (05) years.
