As per the Principle Approval vide letter No.FC-6/GJC-27/2022-GNR 30th Oct-2022 Issued from DIG & RO. IRO Gandhinagar, Diversion of 7.1730 ha Reserved Forest land for laying of overhead 66KV Ubsal Vijaynagar Power Transmission line passing through the village Jaloti, Garada, Bhatera and Saroli, Ta.Vijaynagar, Dist. Sabarkantha favor of Executive Engineer, GETCO, Himmatnagar. The Compliance of Conditions are as follows.

| 1 | The User Agency at its cost shall provide bird deflectors, which are to be on upper conductor of transmission line at suitable intervals to avoid bird hits. | The Bird guard will be fixed at cross arm peak of each tower for safety of Birds |
| 2 | The User Agency shall have to install 4 meter higher than prescribed (As the tower height can be increased upto 6 meters higher than prescribed) towers so that maximum number of trees will be saved from felling under the transmission line. | Already implemented as per technical feasibility |
