- g) The CA plantation shall be taken place before end of 2021monsoon.

4 The cost of compensatory afforestation at the rates compensatory prevailing wage as per afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
