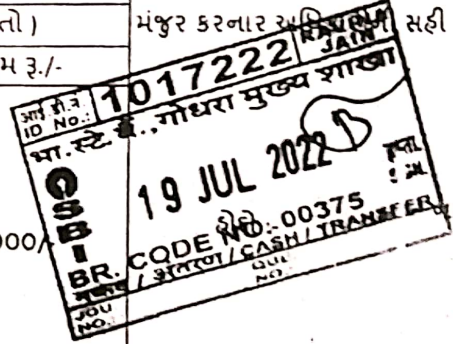

**Sub : Issuing of FRA (Forest Right Act.2006) Certificate.**
