With Reference to the above as it to submit that the proposal, In-principle (Stage-1) approval of Government of Gujarat under Forest (Conservation) Act. 1980 for diversion of 0.9391 ha (Initially 0.80 ha) Reserve Forest for the construction of New Filter Plant, R.C.C. U/G Sump and Pump House for drinking water supply facility in 20 village of Godhra Taluka, Village Gollav, Taluka Godhra, District Panchmahal in Gujarat State. Forest land has been accorded in-principal approval by GOI; vide its letter under reference with certain conditions. Accordingly the action taken / compliance report is submitted as under.

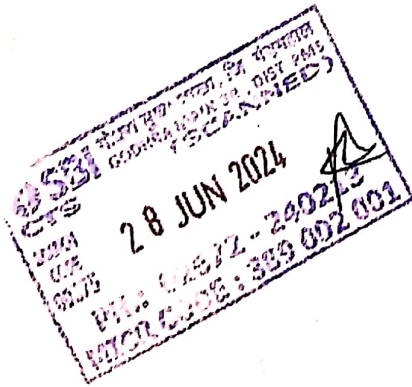

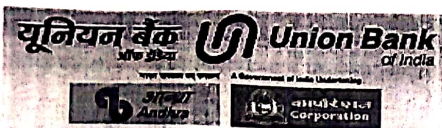
