



## JUSTIFICATION FOR CHANGE OF CA SITE

It is submitted that 5.0 hectare of forest land in Barsai-III (UPF) under Naggar Forest Range was proposed for CA in lieu of diversion of 2.4957 ha. of forest land for construction of Pakhnoj-II SHEP (5.0MW). The MoEF & CC, GoI accorded "in- principle" approval on dated 28.07.2023 and accordingly compliance report to "in-principle" stipulations was submitted online through Parivesh Portal to MoEF & CC, GoI by the user agency. Thereafter, MoEF & CC, GoI vide letter No.I/68694/2024 dated 27.03.2024 raised observations regarding mutation of CA land in favour of State Forest Department and copy of notification of said UPF as PF under IFA, 1927.

As such, the earlier proposed CA site is unmeasured land with no revenue records and is governed Under working Plan and maintained by State Forest Department. Further, the matter regarding mutation of CA land has already been taken with Revenue Department by the Forest Department. The user agency has also made hard efforts for revenue record of the CA area but the settlement of area wherein the CA site is located has not been carried out by the Settlement Office and same will require long time. The User agency has submitted that they have made huge financial arrangements for the project through loans and it is imperative for them to get the project functional as soon as possible to clear the debts. As such, almost one year has elapsed after the "in-principle" approval but final approval in the proposal could not be obtained due pending revenue documents. Therefore, keeping in view the facts narrated herein above and as per request of user agency, the CA site has been revised with 5.0 ha. of forest area in 1/10 Padri Chalon (DPF) area bearing Compartment/Survey No.C-III /52H/4 in Khakhnal Beat, Naggar Forest Range. Accordingly, all the revised CA documents viz. toposheet, digital map, CA area KML, CA Scheme, land suitability certificate and copy of Working Plan have been submitted to MoEF & CC, GoI.

Therefore, keeping in view the request of user agency and facts narrated above, the change of CA site is requested and recommended in this project and necessary permission for the same may kindly be accorded please.
