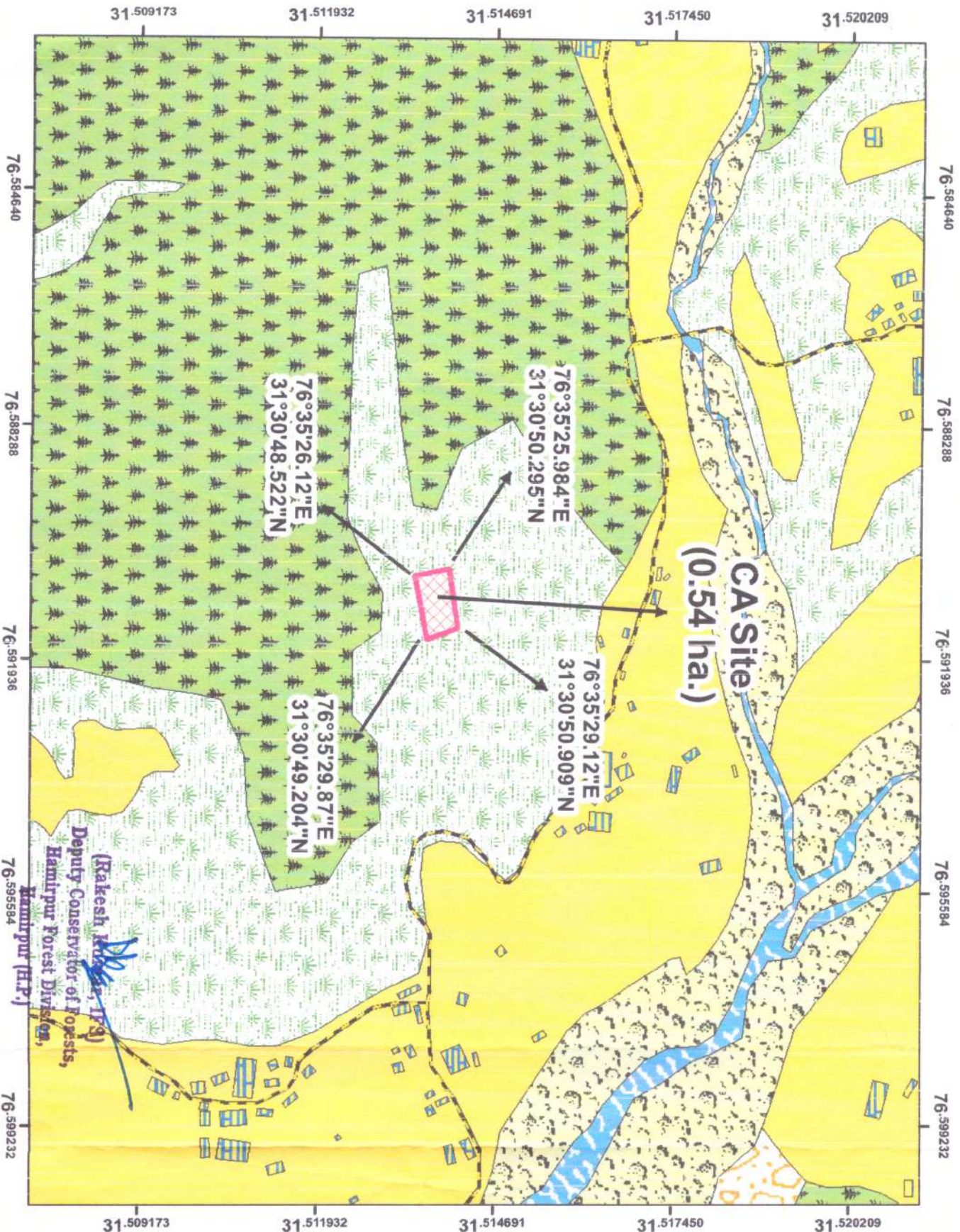

CA Site For C/O National Center Of Excellence At Hamirpur H,P (0.54 ha.)



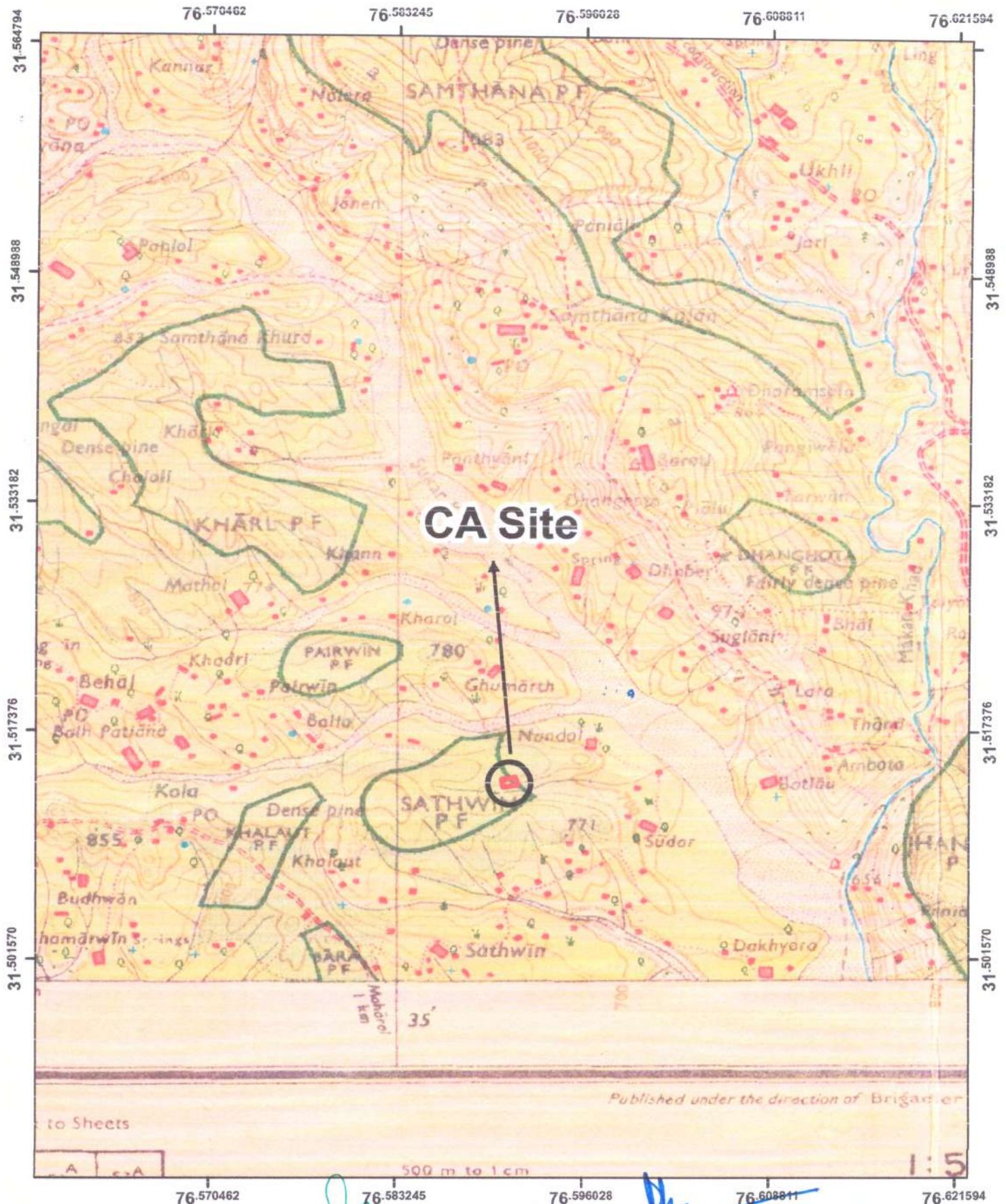
