I, Shivaji Chauhary (Authorised Signatory) ,Bharat Petroleum Corporation Ltd. Hisar hereby undertake for our Proposed Retail Outlet of Reliance BP Mobility Ltd. at Kakrod on UchanaKalan - NacharKhera Road, Tehsil UchanaDistt. Jind , Haryana, Khasra No. 102//24/2. (Proposal No :FP/HR/Approach/152870/2022)

1. Legal status of the forest land shall remain unchanged.
2. The number of trees/plants to be felled shall not in any way exceed the number indicated in the proposal and no harm shall be done to the wildlife during felling of trees. The felling of trees/plants will be carried out under the strict supervision of the State ForestDepartment and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department.
3. The diverted forest land shall not be used for any purpose other than that specified in the proposal.
4. We shall pay additional amount of NPV as and when increased by the order of MoEF&CC or any Court and Divisional Forest Officer will ensure that the increased amount is deposited.
5. We shall pay additional amount of NPV as and when increased by the order of MoEF&CC or any Court and Divisional Forest Officer will ensure that the increased amount is deposited.
6. We shall obtain the permission again after 15 years under the extant Rules under Van (Sanrakshan & Samvardhan) Adhiniyam,1980
7. No damage will be done to the adjoining forest land. Simultaneously, all efforts will be made to save adjoining forest and forest land.
8. The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam,1980.
9. The layout plan of the proposal shall not be changed without prior approval of Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam,1980.
10. We shall carry out muck disposal at pre-designated sites as per the approved scheme.
11. We shall comply with if any other condition stipulated by Divisional Forest Officer from time to time, in the interest of conservation, protection and development of forests & wildlife.
12. We shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
13. Light Crown trees should be planted at an interval of 1.0 to 1.5 meters on the entire periphery of the petrol pump leaving 1.5 meters space from the wall.
14. We will also carry out plantation on the access road (Entry/Exit OrDeceleration/ Acceleration) and on the Separator Island. Further this separator island will not be used for any kind of commercial purpose.


