1. That we shall not change the condition of forest land.

- 2. That we assured The number of trees/plants to be cut will not in any way be more than the number given in the proposal and no harm will be caused to wildlife during the felling of trees. The felling of trees/plants will be done under the strict supervision of the State Forest Department and the We will deposit the amount incurred in felling of trees/plants to the State Forest Department.
- 3. Forest land will be used only as shown in the proposal.

4. That we shall pay NPV amount if NVP change increase in future.

- 5. We agree that this proposal will be given permission for 15 years, after which this permission will have to be obtained again from the Government of India. The period of Diversion under this approval will be co-terminus with the period of lease granted in favour of the user agency or the period of the project, whichever is shorter.
- 6. That we shall not damage adjoining forests and land. We shall make all efforts to save the forest and forest land.
- 7. That the diverted land shall not be transferred to any agency/department/another person without the permission of the Central Government
- 8. That we shall not change in layout plan without permission of the central Government.
- 9. That we shall carry out muck disposal at pre-designated sites as per the scheme approved.
- 10. Any other condition can be imposed from time to time by this regional office for the conservation, protection and development of forest and wildlife.
- 11. If required, the user agency will obtain environmental amendments as per the Environment Protection Act, 1986.
- 12. then we /user agency will be bound to take its permission. If any other related act is applicable.
- 13. It is declared that if we violate any of the above, it will be in violation of the Forest Conservation Act, 1980 and the guidelines laid down in the Ministry's Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines and Explanations), 2019. Action will be taken as per Environment, Forest and Climate Change 1.21.
- 14. That we shall be planted **Light Crown** trees should at an interval of **1.0** to **1.5** meters on the entire periphery of the petrol pump leaving **1.5** meters' space from the wall.

15. That we shall be planted The user agency will also carry out plantation on the access road (Entry/Exit Or Deceleration/Acceleration) and on the Separator Island and this separator island will not be used for any kind of commercial purpose.
