Jhajjar

I do hereby solemnly affirm and declare as under :-

1. General Conditions

1. Cost of Compensatory Afforestation/Additional Compensatory Afforestation as per C.A. scheme submitted by you, shall be realized from the user agency.
2. Net Present Value (NPV) of the forest land 0.0053 hectare being diverted for non forestry purpose shall be realized from the user agency, as per Ministry' directions issued vide letter No. 5-3/2011-FC (Vol-1) dated 6 January 2022 and Hon'ble Supreme Court of India's Order WP (C) No. 202/1995, I.A. No. in 566, dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008.
3. The Net Present Value (NPV) of the forest land all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in.
4. User agency shall ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
5. Compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the Concerned District Collector.
6. Complete compliance report will be uploaded in the e-portal (<https://parivesh.nic.in/>)

2. Standard conditions:

1. Legal status of the forest land shall remain unchanged.
2. The number of trees/plants to be felled shall not in any way exceed the number indicated in the proposal and no harm shall be done to the wildlife during felling of trees. The felling of trees/plants will be carried out under the strict supervision of the State Forest Department and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department.
3. As per the proposed CA Scheme, Compensatory afforestation (CA) shall be taken up by the State Forest Department over degraded forest land in **Marot Minor RD 0 to 6 Right Side by planting 114 plants** at the cost of the user agency. The Plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall strictly be avoided.
4. The Divisional Forest Officer shall ensure that the approved CA site will not be changed without the approval of Competent Authority.
5. The State CAMPA Authority shall ensure that the funds under State CAMPA are released to Divisional Forest Officer as per approved CA scheme.
6. The Divisional Forest Officer shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation in the E-Green watch portal of FSI, before handing over of forest land to the user agency.
7. The diverted forest land shall not be used for any purpose other than that specified in the proposal.
8. The user agency shall pay additional amount of NPV as and when increased by the order of MoEF&CC or any Court and Divisional Forest Officer will ensure that the increased amount is deposited.
9. The initial permission is given to this proposal for **15 years**. After that the permission shall again be obtained under the extant Rule under Van (Sanrakshan & Samvardhan) Adhiniyam, 1980.
10. No damage will be done to the adjoining forest land. Simultaneously, all efforts will be made to save adjoining forest and forest land.
11. The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam, 1980.
12. The layout plan of the proposal shall not be changed without prior approval of Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam, 1980.
13. The user agency shall carry out muck disposal at pre-designated sites as per the approved scheme.
14. Any other condition may be stipulated by Divisional Forest Officer from time to time, in the interest of conservation, protection and development of forests & wildlife.
15. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
16. It will be the responsibility of the Divisional Forest Officer/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal.
17. Violation of any of these conditions will amount to violation of Van (Sanrakshan & Samvardhan) Adhiniyam, 1980 and action would be taken as per the guidelines issued by MoEF&CC.

3. Specific Conditions:

1. Light Crown trees should be planted at an interval of 1.0 to 1.5 meters on the entire periphery of the petrol pump leaving 1.5 meters space from the wall.
2. The user agency will also carry out plantation on the access road (Entry/Exit or Declaration/Acceleration) and on the Separator Island. Further this separator Island will not be used for any kind of commercial purpose.

After receipt of the compliance report on the fulfillment of the conditions mentioned above, the proposal shall be considered for final approval under the van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Transfer of forest land shall not be affected till final approval is granted by the Government in this regard.





