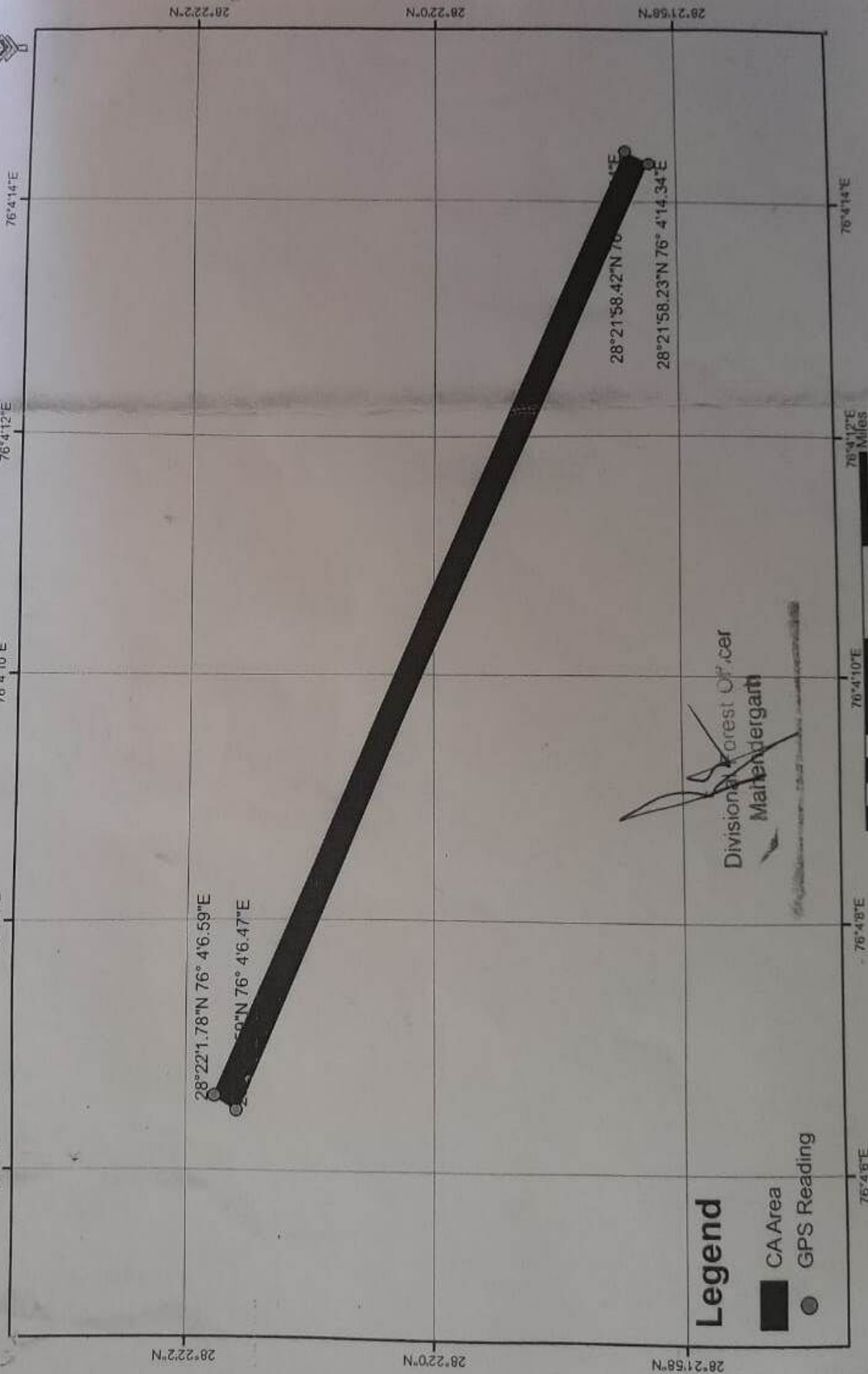

1. That we shall not change condition of forest land.
2. That we assured you the minimum tree / plant shall be cut and no cutting more than 10 no.
3. That we shall use forest land only for entry / exit for the fuel station.
4. That we shall pay NPV amount if NPV change increase in future.
5. That we shall again obtain NOC after 15 years.
6. That we shall plantation of light crown tree within 1.50 M periphery boundary of fuel station.
7. That we shall plantation the plant in entry / exit and separator is land. No commercial use of the island.
8. That we shall not damage adjoining forest and forest land. We shall make all efforts to save the forest and forest land.
9. That the diverted land shall no be transferred to any agency/deptt. /other person without the permission of the central government.
10. That we shall not change in layout plant without permission of the central government.
11. That we shall dispose of the garbage as per plan.
12. That we shall be no objection in the condition applicable by regional officer for protection and development of wind animal.
13. That we shall obtain NOC from pollution department if required.
