Diversion of 1.8239232 ha. forest land in favour of Executive Engineer, Provincial Division, PWD B&R Nuh (Mewat) for Construction of Ring road from Tauru road to Alwar road via Engineering College, Medical College and Navodaya School Bai in Nuh Distt. (C.M. Announcement 15242) (Online proposal No. FP/HR/ROAD/ 27251/2017)

In this connection, it is submitted that the first stage permission for diversion of 1.8239232 ha. forest land for the work cited as subject was received from the Regional Office, Chandigarh vide letter under reference with the condition that "Mutation and transfer of CA land (Non Forest) in favour of Haryana Forest Department". This office is not in position to mutation and transfer of land CA land (Non Forest) in favour of Haryana Forest Department due to following reasons:-

- 1. The Protected Forest land of 1.8239232 ha. which was diverted in favour of Executive Engineer, Provincial Division, PWD B&R Nuh (Mewat) for construction of Ring road from Tauru road to Alwar road via Engineering College, Medical College and Navodaya School Bai in Nuh Distt. (C.M. Announcement 15242) (Online proposal No. FP/HR/ROAD/ 27251/2017. The same land was not owned by forest department and this land belongs to Haryana Irrigation Department. The management of this land was given to Forest Department under Forest Conservation Act, 1980 for Forestry purpose only. This land was neither owned by forest department nor transferred Forest Department by the Irrigation Department. Due to this, the ownership of this land is not of your department.
- 2. As per online form of part-I for diversion of Forest land, this department was agreed to offer the land for CA site in lie of forest land of 1.8239232 ha. The CA land belongs to this department and this land is located on four lanning road of old GA road to Govt. Medical College Nalhar (11 feet wide both side of road). The site plan for this land is attached for ready reference.
- 3. Now, this land is again offered to your department for CA site and notification under Forest Conservation Act, 1980 in lie of diversion of 1.8239232 ha. Forest land vide online proposal No.FP/HR/Road/27251/2017.



- 4. Keeping in view, as explained above, it is requested to your department for taking up the CA site land and same CA site land may be notified with the name as "Four lanning road of old GA road to Medical College road" under forest conservation act, 1980 in lie of diversion of 1.8239232 ha. forest land vide online proposal No. FP/HR/Road/27251/2017.
- 5. The road has to be constructed on the existing service road of Nuh Distributory. The same existing service road is being used for inspection of Nuh Distributory by Irrigation department. The NOC for construction of road was taken by PWD department from Irrigation department. (NOC attached)
- After notification of CA land under Forest Conservation Act, 1980 and taking the management on this road, the final permission of diversion of 1.8239232 ha. forest land vide online proposal No. FP/HR/Road/27251/2017 may kindly be got arranged from the RO office Chandigarh.
- 7. During the review meeting regarding CM announcements with the all administrative secretaries on 06/05/2023 and meeting chaired by Hon'ble Chief Minister, Haryana. It was decided in the meeting that the all CM announcements which announced between 2015 to 2020 should be commissioned at the earliest without further delay. This work falls under CM announcement vide code No.15242 dated 23/10/2017.


