
This is to bring to your kind attention that, In-principle approval for non-forestry use of 133.64 ha of forest land for rehabilitation of village Latu from Palamau Tiger Reserve to Polpol Kalan PF of Kundri Range, Medininagar Forest Division, District Palamu (Jharkhand) was granted by Ministry of Environment, Forest and Climate Change, Government of India vide Letter dated December 2022 subject to a total of five conditions which needed to be complied prior to handing over of forest land by the State Forest Department.

The compliance report of the conditions is submitted hereunder :

Sr. No.	Condition	Compliance
i.	The area of Palamau Tiger Reserve to be vacated shall be mutated in the name of State Forest Department and notified as RF/PF	The villages to be resettled namely Kujrum and Latu are forest villages situated inside the Core Area of Palamau Tiger Reserve and are already part of Baresanr Reserve Forest.
ii.	The State Government shall obtain approval of the Standing Committee of the NBWL as some portion of the area proposed for rehabilitation falls within the buffer area of the Tiger Reserve.	In this regard, it is to clarify that the area proposed for diversion (133. 64 ha) at Polpol Kalan PF, Kundri Range, Medininagar Forest Division falls entirely outside the notified boundary of the Buffer area of Palamau Tiger Reserve. It also does not fall within any other Protected Area. Hence, permission from NBWL is not required. The map of the proposed area for diversion along with the map of the Buffer area of Palamau Tiger Reserve is enclosed with the attachment as Annexure - A.

iii.	The correct and complete KML files of the area proposed for diversion, area of Palamau Tiger Reserve to be vacated shall be uploaded on the e- Green watch portal with all requisite details before handing over the forest land to the user agency	The undertaking of the same is attached as Annexure - B.
iv.	The State Government shall ensure that complete process for recognition and identification of rights as per the provisions of the Forest Rights Act, 2006 has been completed in the area proposed for diversion and area of Palamau Tiger Reserve proposed to be vacated in accordance with the relevance guidelines issued by the Ministry in this regard and compliance of the same shall be submitted along with Stage-I compliance	The villagers of Kujrum and Latu forest villages have been given individual and community forest rights. The District Welfare Officer, Latehar has given certificate for recognition of rights in these villages. The same has been attached as Annexure - C.

It is further certified that :

- (a) The complete process for identification and settlement of right under the FRA has been carried out for the entire 568.10 Acre of forest land proposed to be diversion. A copy of records of all consultation and Meeting of the Forest RIGHT Committee (s). Gram Sabha, Sub-Division Level Committee and the District Level Committee are enclosed.
- (b) The proposal for such diversion (with full details of the project and its implication in vernacular/local language) have been placed before each concerned Gram sabha of Forest dwellers, who are eligible under the FRA.
- (c) The each of concerned Gram sabha (s), has certified that all formalities/processes under the FRA have been carried out and that they have been given their consent to the proposed and diversion and the compensation ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of Pokhraha Khurd village is enclosed.
- (d) The discussion and decisions on such proposals had taken pace only when there was quorum of minimum 50% of the member of Gram sabha present.
- (e) The diversion of forest land for facilities managed by the Government as required under section,3(2) of the FRA have been completed and the Gram sabhas have given their consent to it.
- (f) The rights of Primitive Tribal Group and Pre-Agricultural Communities, where applicable have been specifically safeguarded as section 3 (1) (e) of the FRA.
